Minutes:

Chairman Kelsch opened the hearing on **HB 1362**.

Rep. Hanson introduced the bill. This bill is similar to the bill we had two years ago. At that time we amended it to eliminate anybody trying to recruit students from one district to another through advertising in the media. This bill simply states that if a student from District A wants to go to District B and District B wants to provide the transportation, it must be approved by District A. They have gotten around that by using Letters to the Editor, which is freedom of speech, and some of districts are getting students out of Jamestown. On the handout that I gave you (**attached**) there are 114 students from Jamestown being open enrolled to smaller towns around Jamestown. Some drive on their own, but there is one district that sends buses directly into Jamestown and picks up 50 or more students at one time.

Joe Sykora, business manager, Jamestown Public Schools, testified in favor of the bill.

(Testimony attached.)

Rep. Sitte: Why would this happen? Why would people want to go schools other than Jamestown?

Sykora: There are many reasons for students wanting to leave Jamestown. Some would be smaller class sizes, perceived drug problems, removal from undesirable peer groups, distance to walk.

Chairman Kelsch: Another reason may be sports, more students compete for teams. It's not just academic.

Rep. Hunskor: Most parents don't want their younger children to bus too long. Do you find it's more the older students who are riding the bus out of Jamestown?

Sykora: The students range from K through 12, it spans all the grades.

Rep. Johnson: There are 114 going out. How many are coming in?

Sykora: About 33-34 students coming into Jamestown.

Rep. Mueller: On those 34 coming into Jamestown, what's their transportation situation?

Sykora: The parents are responsible to bring the students to our resident area or to the schools directly for educational services. If they're living on the outer fringes of our district, we ask them to come into the district and we pick them up.

Rep. Sitte: Would the block grant for transportation be favorable to your district?

Sykora: Kinda switching gears to the transportation efficiency study? We lost \$6 - \$7000 in the first report. We are looking at different ways to become efficient. One bus goes around an specific area, they meet, and then disburse to our schools. The efficiency in the rural community is going to be more difficult. It's going to take longer and you need a larger capacity bus.

Rep. Sitte: When you look at some of the smaller districts around you, they are facing declining enrollment in their locale. If they can run a bus to Jamestown and gain 70 students, for them it's the most cost efficient way to improve their school that they could ever hope to find. With NCLB you have this open enrollment where people have the right to choose where they want to go. This is a major component of NCLB is that transportation be provided. Aren't you running counter to what's coming down the road anyway?

Sykora: I would have to disagree with you. NCLB provides options to parents within in school district. Parents have the opportunity to move their student from one school to another in the district in terms of school choice. The competition in the past in terms of school district boundaries, is that we are not looking at students as a commodity that represents \$3000 in state revenue. If we want to rework the environment, we'd have to change a lot of different bills in terms of looking at it in a different light.

Tom Decker, DPI, testified in opposition of HB 1362. He distributed a sheet showing how many students were open enrolled into and out of each district in the state this year. **(Attached.)**

As the scan through the list you will note that many larger districts have a significant number of students open enrolled out, most also have some number of students coming in. The fundamental value here is open enrollment. I think it's the best thing the legislature has done for students in ND. We should guard the option that we gave parents to choose the school attendance of their choice zealously. The open enrollment statute does not require parents to give a reason why they want to open enroll their students. We did that intentionally. The recruiting part of the statute we passed a couple of years ago is difficult to enforce. We monitor a couple of situations and look for opportunities to pursue enforcement, but it's difficult to find those.

You need to understand that transporting open enrolled students is now and always has been optional. Neither district is required to, either district may. We're having discussions on models now where we simply do not provide transportation for open enrolled students. We believe that is an appropriate position because the districts that receive the students get state aid and that more than covers the transportation costs, or certainly should. Duplication of services is a small price to pay to have the option of open enrollment. Passing this bill would give districts a very effective, probably a lethal weapon in the openness of open enrollment. I strongly urge you not do anything to impede the free flow of open enrollment. This bill would do that.

Chairman Kelsch closed the hearing on HB 1362. The bill will be held to see how it would fit with the other bill on transportation we are dealing with.

Chairman Kelsch opened discussion of HB 1362.

Rep. Hanson: I think we have done something in the transportation bill to eliminate mileage going into another district. I don't know how we would keep track of that. We really have a problem in Jamestown and Mandan is even worse than ours on enrollment out. I would like to see the bill passed but it might hurt some districts, but it would really improve ours. We have close to \$400,000 we're losing. This would stop districts coming in and picking up 50 - 60 kids in one parking lot.

Rep. Herbel: Would this discourage the concept of open enrollment?

Rep. Hanson: I don't think so because the school district can give approval. For example we have some on the outer edges of our district that we would let go easily.

Rep. Herbel: I like the idea of open enrollment, but the idea of recruiting again, that's a whole different story.

The Jamestown School Board supports HB 1362 as it relates to transportation for open-enrolled students. The bill addresses two issues. First, transportation is used as the recruitment "tool" to influence families. Second, the duplication of educational efforts by neighboring schools causes additional expenditures of public funds for education. HB 1362 resolves the two issues noted above by having a school district petition the resident district for transportation into a district before proceeding.

Open enrollment provides families with opportunities to select a school in which they would like to attend for personal reasons. Standards for open enrollment are clear in terms of acceptance, denial, or in influencing students or the student's family about the participation in the open enrollment program. North Dakota Century Code (NDCC) 15.1-31-06 notes that transportation aid payments can be withheld if a complaint is found to be true. However, no penalty can actually be given because the current language in NDCC 15.1-31-05 allows bussing to occur while "masking" the issue of enticing families and students.

With changing demographics in North Dakota, it would appear the recruitment of students is intensifying due to possible consolidations, school closings, and the attachment of state revenue to enrollment. School district boundaries were established with the theory that districts should not have to compete for students in order to survive. Open enrollment further adds to the grey areas. Is education moving towards an environment of competition, like when Coke and Pepsi compete for market share?

The second issue addresses two different school districts bussing students from the same "space." This is duplicating efforts and causes additional local and state funds to be used for education. State revenue for transportation in 01-02 and 02-03 is the same amount that districts receive in "block" transportation payments in 03-04 and 04-05. Mileage and student ridership in 01-02 and 02-03 was used to determine revenue in 03-04 and 04-05, and thus bussing is indirectly supported by state revenues for duplicating transportation efforts.

As you know, school districts in North Dakota span many square miles with few students in the rural areas. There are times where it would make sense to allow a bus to enter into a school district to pick up an open enrolled student on the outer edge of a district. For example, when a student lives 30 miles from the resident district school and 5 miles from the open enrolled school, it would make sense that the districts can agree to allow bussing into the resident district area. There is no duplication of efforts by two school districts and there is no recruitment of students taking place because of transportation.

In summary, exerting influence in order to encourage open enrollment is hard to define and to substantiate. However, with changing demographics, school consolidations, and state foundation aid tied to enrollment, you know "it" when you see "it" thus the need for HB 1362.

15.1-31-06. Open enrollment - School boards - Standards.

1. The board of each school district shall set standards for the acceptance and denial of applications for admittance under open enrollment as provided in section 15.1-31-01. The standards may address the capacity of a program, class, grade level, or school building. The standards may not address previous academic achievement, participation in extracurricular activities, disabilities, English language proficiency, or previous disciplinary proceedings.

2. A board may also determine that applications for admittance under open enrollment, in accordance with this chapter, will not be considered.

3. a. A school district participating in an open enrollment program may not give or offer to give a student remuneration, or directly exert influence on the student or the student's family, in order to encourage participation in the open enrollment program.

b. For purposes of this subsection, directly exerting influence means providing information about the school district to individuals who are not residents of that district unless the information is requested.

c. If the members of the board of a school district believe that another school district has violated this subsection, the board may file a complaint with the superintendent of public instruction. Upon receipt of a complaint alleging a violation of this subsection, the superintendent of public instruction shall hold a hearing and accept testimony and evidence regarding the complaint. If the superintendent finds that a school district has violated this subsection, the superintendent may withhold some or all of the transportation aid payments to which the district would be otherwise entitled for a period of one year from the date of the finding. A decision by the superintendent under this subsection is appealable to the state board of public school education. A decision by the state board of public school education is final.
