Chairman Price: We will open HB 1209.

Representative Kenton Onstad, District 4: See attached. In other states you can go directly to a dental lab with out going through a dentist, increasing the bill. I urge a do pass.

Jake Tiessen: I have charges with me for teeth replaced for my wife. I think the charges from dentist are highway robbery, and I have the bills to show you. In another state we were able to do right to the lab.

John Cichy, ND Dental Association: The board opposes. They think it would be over burdensome. Itemizing of a dental bill is very time consuming.

Representative Schneider: Is there a mark up on fees when the dentist uses a 3rd party?

Dr. Terry Deeter, practicing dentist in Bismarck and President of the ND Dental

Association: As in many small businesses, yes there has to be an additional cost. We are a business, as some of you may understand that you have costs and overhead. Dentists could do the work, but many choose to go outside the office. If we didn't have a mark up we would not be in business very long.

Rita Sommers, NDSBDE: This would create a night mare of record keeping. Some have in house labs. They than pay someone to do this, plus the supplies and machines they would

need. We oppose this bill. There are no set fee schedules in dental offices and what they charge. There are many levels of dentistry.

Chairman Price: Any more opposition. We will close the hearing on HB 1209

2007 TESTIMONY

HB 1209

Madam Chair Price and members of the Human Services Committee,

I am Representative Kenton Onstad, District 4.

HB 1209 is simply about disclosure. It basically says if a dentist uses the service of a third party, they shall itemize the patient's bill showing the cost of those services utilized.

Currently in North Dakota, you cannot go directly to a dental lab to have work done on a denture, plate or bridge, unless you are referred through a dentist. In other states, like our neighbor Montana, you can go directly to a lab for services. This referral adds extra expense to the bill.

North Dakota does not regulate dental labs and therefore they have to go through the dentist. The dentist is regulated and therefore responsible that services are properly taken care of.

The question is are the charges by a dentist because of current practices in North Dakota in line, warranted or even necessary.

Committee members HB 1209 simply asks that all charges for the third party and dentist be disclosed in the bill.

Thank you for your considerations and I hope you can give HB 1209 a Do Pass.
