Minutes:

Vice Chairman Meier opened the hearing of HB 1261.

Representative R. Kelsch, District 34, introduced the bill relating to the proper naming of schools. This is a simple bill and says that in a reorganization of a school district that the name change must include the phrase "school district" or "public school" and may not include more than two additional words. The reason is that we want to continue promote consolidation and reorganization; however, what happens is that when you get 4 or 5 districts coming together it becomes a muddled issue. When you consolidate, you are becoming a new district and you are a district that needs to move forward. Sometimes we look at what was rather than what will be. In listening to the sports at night you can hear the names of all places they were. That's not what they are anymore. It's extremely important to move forward to move forward with the education system and we look at these consolidations as a new school district and that's what they become. You are representing more than one town. Realistically we need to ask who are we are going to be and it should be meaningful and actually represents what the district is going forward not who they were in the past.

**Representative Herbel:** This doesn't apply to co-op athletic programs?

Should it?

**Representative Kelsch:** It does not, but it could. In athletic programs they could at least go down to initials or something different.

Representative Hunskor: I think of Lewis and Clark. There are three words in there.

Representative Kelsch: Articles don't count. -nor conjunctions.

**Tom Decker, director of School Finance, DPI** testified in favor of the bill. **(Testimony Attached.)** There is an article in the paper today of a good example. Three towns coming together shortly and their new district will be called North Start. So they are taking on a new identity.

**Representative Mueller:** I don't disagree with the concept at all. Is there any concern here that we could be setting up an impediment that would dissuade or discourage potential school consolidations?

Decker: If that issue will hold up reorganization, we have bigger problems than that.

**Representative Karls:** Does that mean Hazleton Moffit Braddock is out the door. Are any grandfathered.

**Decker:** This is not retroactive. It is for consolidations moving forward.

Representative Haas: An observation: I have never seen one of these reorganizations where the students were an impediment. They adjust over night. It's the old folks in the community that are fighting these things. If you allow people to begin a new tradition, they will begin a new tradition. That is something that we need to allow our students to begin a new tradition based on the new name, a new concept and a new togetherness. That's the reality of how that works.

Representative Kelsch: Just a comment on what you said. I was a product of the consolidation of Mayville Portland. I was truly excited about it and I remember my parents arguing about it. I was disappointed when we were Mayville Portland. There was still that tug

and pull and I wish we would have started with a new name. That's why I always admired

Central Cass because I thought they had the right idea.

Representative Herbel: How long did it take your community to get over being Mayville

Portland?

Representative Kelsch: About a nanosecond.

**Representative Hunskor:** If we pass this bill, it's up to the community to decide if they want to go ahead with this name change and it could be retroactive in each community if they wanted to that but they are not required.

**Representative Kelsch:** This is for reorganization going forward. This would not affect reorganizations that have already occurred.

Minutes:

Chairman Freborg opened the hearing on HB 1261, a bill relating to the naming of a school district. Senator Taylor was absent.

Tom Decker, Director, School Finance and Organization, Department of Public Instruction, testified in favor of the bill. (Written testimony attached)

Chairman Freborg asked if letters count as one word, for example would TGU be one word or three.

Mr. Decker said they would consider TGU to be one word as would New Rockford.

Senator Bakke asked for an example of how this could be a problem.

Mr. Decker said TGU could be Towner Granville Upham. He is working with 5 districts in

Kidder County that are considering reorganization. The sports casts are full of examples.

Senator Flakoll asked if any districts would be able to reorganize before this law could go into effect.

Mr. Decker said he is not aware of any districts that could be ready to move that quickly.

Senator Flakoll asked if the department had ever considered requiring approval of school

nicknames or mascots.

Mr. Decker said he has tried to stay away from that.

Senator Flakoll asked if a number is in the name if that counts as a word.

Mr. Decker said the bill applies to words that come before the words School District. All school districts have a number.

Senator Gary Lee asked if there is a need for this change.

Mr. Decker said there are 167 school districts in North Dakota with high schools. 90 of them have 100 or less students. In 3 years, another 20 will have 100 or less students making 110 districts with 100 or fewer students. The possibilities for reorganization are considerable. In his experience, its best to use a neutral name for a reorganized district, Lewis and Clark is an example. Then the new district has a new identity.

Senator Gary Lee said sometimes there is not much room for different names, they have Central Cass, could have Western Cass, Southern Cass, he has 9 school district in his district. Senator Flakoll said who knows where United is? Is that a cause for concern?

Mr. Decker said for 41 years we have had these situations. Kidder County Public Schools is descriptive.

Chairman Freborg closed the hearing on HB 1261.

Senator Flakoll moved a Do Pass on HB 1261, seconded by Senator Bakke. The motion passed 3-1-1. Senator Bakke will carry the bill.

# TESTIMONY ON HB 1261 EDUCATION COMMITTEE

January 23, 2007 by Thomas Decker, Director, School Finance (701) 328-2267 Department of Public Instruction Jestinonto.

Chairperson Kelsch, members of the committee, for the record, I am Tom Decker, Director, School Finance & Organization, Department of Public Instruction.

House Bill 1261 should be viewed as a house keeping bill. It inserts provisions in law regarding the official name of the school district.

Page 1 of the bill requires that the name should include school district or public school district and no more than two additional words.

Page 2 of the bill requires the same name characteristics when the school district is formed through the school district reorganization process.

At a period of time when up to five school districts in a county are considering possibly reorganizing into a single new district, the possibilities for very long names of school districts is there. Some of these very long names you hear every night on sports cast. We've had one instance in which a newly reorganized district did not provide the new districts name in their reorganization plan. Their proposal was to determine the name of the new district through a student contest very much in the way some school districts have chosen a sports mascot.
