Chairman Wrangham opened the hearing on HB 1340.

Rep. Glassheim: Introduced the bill. Passed out letters from the Mayor of Grand Forks (#1) and the Director of Bismarck-Mandan MPO (#2) and the proposed amendment (#3). The purpose of this bill is Metropolitan areas are required by the Feds; cities that are right next to other cities, are required a transportation plan like Grand Forks, East Grand Forks, Fargo-Moorhead, MPO Bismarck-Mandan. Until about a year ago the Grand Forks MPO was part of Grand Forks' transit planning. Grand Forks joined the PERS plan about a year ago. There was some question to whether the MPO employees were eligible to join the PERS plan because they were not a political subdivision and they were not specifically employed by Grand Forks. This bill was introduced to acknowledge what they do and to acknowledge political subdivisions for purposes of getting into the PERS plan.

Chairman Wrangham: This language in here is just moved from another chapter?

Rep. Glassheim: some of the language was taken from another state.

Earl Haugeland, Director of the MPO Grand Forks area: I am here to support this bill. This bill will enable us to join with the NDPERS. Bismarck-Mandan supports it and Grand Forks as well.

Representative Glassheim District #18. Introduced HB 1340. Explained how the Metropolitan

Planning Organization (MPO) retirement plan works and how it would fit into the ND Public

Employees Retirement System (PERS). PERS has no problem with adding the MPOs to the

plan. See attachment #1.

Chairman Andrist Line 6 & 7 of the bill make MPOs a political subdivision so they can be

eligible for PERS. Is that all this bill seeks to do?

Glassheim That is correct.

Senator Olafson Does this involve just a handful of employees?

Glassheim That is correct, a few in Fargo and a few in Grand Forks. Bismarck and Mandan

are supportive of this but they do not need this plan as they have their own plan.

Senator Olafson I also believe you said that there will be no additional cost to the political

subdivision?

Glassheim Yes, in Grand forks they are already covered.

Chairman Andrist Other Grand Forks and Fargo workers are not allowed to be a part of

PERS?

Glassheim That is correct, without this bill those workers are not allowed to be a part of PERS.

Senator Lee Is this the easier of the solutions for Fargo and Grand Forks as opposed to doing this on a local level?

Glassheim We used to have everyone involved covered as city workers until we switched to PERS which than disqualified some workers.

Senator Dotzenrod Why are some MPOs not state/city employees?

Glassheim Explained how MPOs function.

Earl Haugen Director of MPOs. Voiced his support to 1340.

Senator Dotzenrod How are MPOs paid?

Haugen We are paid through the MPO. The majority is from federal funds through the DOT (about 80%). Our local jurisdictions contribute the other 20%. Our primary source of revenue is from federal funds but we are considered a ND entity.

Brian Reinhardt NDPERS. Provided information. We have spoken with our actuary and the attorney general's office and we can accommodate this bill with no additional costs.

House Bill 1340 amends Chapter 24-01 of the North Dakota Century Code to create a new section relating to Metropolitan Planning Organizations (MPO's) to allow certain MPO's in the state to be recognized as political subdivisions. House Bill 1340 would amend Chapter 24-01 of the North Dakota Century Code by creating a new section relating to Metropolitan Planning Organizations (MPOs). It is our understanding that the proposed bill would allow certain MPOs in the State to be recognized as political subdivisions with the purpose of accepting their employees into the North Dakota Public Employees Retirement System (NDPERS). We are supportive of the efforts of the Fargo-Moorhead Council of Governments and the Grand Forks-East Grand Forks MPO to have their employees included in the State's retirement system.
