Senate Human Services Committee Sixty-Third Legislative Assembly of North Dakota House Bill No. 1040 March 13, 2013

Good morning, Chairman Lee and Members of the Senate Human Services Committee: I am David Boeck, a State employee and lawyer for the Protection & Advocacy Project. The Protection & Advocacy Project is an independent state agency that acts to protect people with disabilities from abuse, neglect, and exploitation, and advocates for the disability-related rights of people with disabilities.

House Bill 1040 addresses temporary or emergency guardianships. Under current law, a son could petition to be named temporary guardian of his father by alleging that his father cannot make responsible decisions due to an impairment and that an emergency exists for which a guardian is necessary. A temporary guardianship in these circumstances is routinely valid for 90 days. As temporary guardian, the son could make legally binding decisions for his father and would not have to give notice to his father until fourteen days before a hearing. The hearing would not have to be held until the ninetieth day of the temporary guardianship.

The Protection & Advocacy Project supports House Bill 1040. If enacted, the bill would provide better protection for the constitutional rights of an individual who is allegedly incapacitated. This would greatly improve the fairness of this process.
