# **Explanation or reason for introduction of bill/resolution:**

**Chairman Porter**: opened the hearing on HB 1412, clerk read the title.

Rep. Tveit, Dist.33: presented Attachment 1.

**Chairman Porter**: questions?

**Rep Heinert**: Line 23,24. Did you say it allows anybody on any land without a license?

**Rep. Tveit**: a landowner, leaseholder or renters to pursue predators with the aid of assistance, both with or without a license to pursue and shoot without a license specified predator animals except during that specified season.

**Rep Heinert:** Can you point out to me in law where it says the landowner, leaseholder or renter? (found)

**Chairman Porter**: Further questions? Further testimony in support

Jessie Flath, Hazen: Speaking to Rep Heinert concern. The intent was not to allow people to hunt anyway without a license. I would suggest an amendment, line 23, I would recommend, "an individual with, or landowner or lessee without". Our intention was for landowners to protect their livestock without having to purchase a license. Not all landowners are hunters but they want to protect their depredation, i.e. a rancher calving out for months and long hours on end, has a predator problem but he's too busy or tired so he calls a predator hunter to come take care of it for him. I would recommend language saying an individual with or landowner or lessee without a license. Other intentions were to expand the length of the season. G&F did open up this season a year or two ago to night hunting from the day after deer season until March 15. That date has nothing to do with predator hunting.

We'd like to extend it into the spring, and calving season. There's no language anyway pertaining to infrared which is needed to property use digital night vision.

**Chairman Porter:** Questions? Further support?

**Emery Melhoff, ND Farm Bureau**: We support this bill and suggested amendments.

**Chairman Porter**: Support? Opposition?

Stephanie Tucker, ND Game and Fish presented <u>Attachment 2</u>. Requested a Do Not Pass.

On Line 14 overstrike owl and rabbit. Currently they're federally protected except when doing damage to someone's livelihood. Correct or incorrect?

**Tucker:** I am the furbearer specialist and cannot speak to that. My understanding is they're federally protected even if causing damage. You cannot take one legally even when they're causing damage.

#### Chairman Porter:

G&F does have some concerns, Section 1 not so much, Section 2 opens up any furbearer species to all night hunting and don't feel that some of the populations are able to sustain 24/7 hunting.

**Chairman Porter**: Presented Attachment 1. G&F already does a provision for infrared lights and thermal vision. It's unclear in the proclamation and has always been a question on digital night visions that have it built in. This amendment will clear that up, remove the owl, keeps the landowner or agent in charge on private property, you're not on any public land and neighbors in any danger. It adds a green light which comes factory on night vision devices. Section 2 is unnecessary.

**Rep. Zubke:** I move the amendment.

# Explanation or reason for introduction of bill/resolution:

A bill relating to hunting predators at night with artificial light, digital night vision, thermal vision, or infrared light.

Chair Unruh: Opened the hearing.

Representative Bill Tveit, District 33 (0:40-5:05) Introduced the bill, please see attachment #1 for testimony and #2 for amendment.

Jesse Flath, Hazen Citizen (6:00-11:00) Testified in favor. This bill has had a lot of changes; I was the one that talked the Representative Tveit about 'must' being changed to 'may.' The issue that we're worried about is that infrared does not produce a visible light. If you put 'must' in that line, it will contradict the infrared wording. Visiting with Game and Fish this morning, we get into some really technical stuff. I'm not against changing this however you see fit, I just don't want contradicting language. When you get down to the nickels of it, infrared does produce light. Now we are down to technicalities if there's ever an issue with what's going on. It's a hard one to hammer out, the word 'shall' also means must. If you decide to leave as 'must' because infrared does produce light, you just can't see it, now we're in limbo. Game and Fish has stated that they view it as producing light. You could change the word color to spectrum, but now we get into big words that other people won't like or understand. As Representative Tveit said, I urge you to pass this in a form you are comfortable with, with Game and Fish's input. Right now night vision ends at March 15, which we are past, and everybody is calving. There are rules and laws out there that provide the landowner the capability to use pretty much any means necessary to protect their herd, however, it has to be them. That's where the language in this bill with 'the individual or an agent' that provides the rancher or landowner the ability to assign that duty to someone else. I have rancher friends getting pretty owly this calving season, not getting enough sleep. If they have a predator problem, they don't have the hours in the day to take care of it themselves. It's a two-fold issue we are trying to take care of. The original bill had the timing on the first day of any big game season in our state to the last day of deer season to make sure there isn't anybody trying to use night vision infrared or any other night optics to hunt big game. That was taken away, with the combination of these two bills, you can see the

language in the grey that was added, that also provides penalty. It makes it illegal to use night vision to hunt deer or any other big game. We know that's an issue, and we don't want that. Our stance has been that if someone is going to do that, they are already doing that. But we don't want that legal avenue opened up to them. I'm fine with that combination of bills being there. The big game language, I'm ok with. The issue is 'must' or 'may'; that's a definition problem I'll leave to you.

**Vice-Chair Kreun:** This bill is for hunting and ranching, you indicated that during the evening in calving season, that you do have predators; they are protecting their herd against predators.

**Jesse Flath:** It's a depredation and hunting bill, the ability to use night vision for predators only. You'll see the language, it's fox, coyote, raccoon, and beaver.

Vice-Chair Kreun: It's interesting that they work together, I appreciate you bringing it forward.

Pete Hanebutt, North Dakota Farm Bureau (12:25-12:55) Testified in favor. We are looking out for our livestock owners, we are anti-vermin, and pro using lights to get rid of vermin.

Julie Ellingson, North Dakota Stockman's Association (13:05-13:20) Testified in favor. We support the concept and would be happy to work with the committee as you work through amendments.

Rich Tischaefer, President North Dakota Fur Hunters and Trappers Association (13:40-15:00) Testified in favor, please see attachment #3. With HB 1412, a lot of work has been done. We've blended what we needed to do with SB 2058 into HB 1412. The discussion with 'must' and 'may' will continue, we support the concept of the bill, we appreciate your help.

**Terry Traynor, Association of Counties (15:15)** Some of these critters are awfully damaging to our roadways, plugging culverts, soaking the road, making it difficult and costly. This appears to be a partial solution to that, so we support the bill.

John Bradley, North Dakota Wildlife Federation (15:40) Testified in favor. We are here in support of our affiliate club, the North Dakota Fur Hunters and Trappers Association, they worked hard on this bill, we'd like to see it pass.

No opposition testimony.

Scott Peterson, Deputy Director North Dakota Game and Fish (16:30) Provided neutral agency testimony. North Dakota Game and Fish supports the concept of allowing artificial light, infrared, night vision, thermal imaging, what we are trying to do here is allow the use of that for North Dakota sportsmen, women and landowners for hunting fox and coyote at night, and make sure we don't allow enough flexibility in law to allow people to spotlight for big game. The only question we have is about that one word that is proposed to change from 'must' to 'may', I'm not certain how that needs to be worded, we think leaving that as must, because the sentence is specific to artificial light, if the sentence says artificial light must

produce green, I think we are still ok, but that may be a question for legislative council. Other than that, we are in support of HB 1412. There's an amount of uncertainty about what changes that one word will make. We agree on what it's trying to do, we just need to be certain that if we leave 'must' in there, because infrared is considered an artificial light the sentence will be ok because it specifically references artificial light. Maybe it would clarify if we said artificial light including infrared? Maybe not.

Robert Timian, Chief Game Warden, North Dakota Game and Fish (18:55) As it's written on page 1, line 17, this is for the hunting portion, the rancher can do whatever he wants in protection of his property, it lists artificial light, night vision, thermal vision, or infrared light with a power source may be used for the hunting of coyote, fox, raccoon, or beaver during the open season. It cites four different types of equipment. On line 19, the end of the sentence, 'the artificial light,' it's only referring to the artificial light as stated in line 17. We're saying that 'must produce a red, green, or amber color when hunting coyotes or fox. It's not referring to night vision, thermal vision or infrared, it's only referring to the artificial light, which is mentioned in the first one, and the reason for that is they can't use a flashlight and go shining, it has to have a filter.

**Chair Unruh:** We'll think about this for a while. Closed the hearing.

**Chair Unruh:** We had some amendments with HB 1412, and there was quite the conversation on page 1, line 18, switching 'must' to 'may,' game and Fish was trying to sort it out, with the bill sponsor. After a bit of discussion, they decided that 'must' should remain. Representative Tveit had given us amendments, that everybody does want. The only change on that would be on the amendments that were handed out **(please see attachment #1, page 1)**, 19.1057.02001, on page 1, line 17, replace 'must' with 'may,' that can get removed, and the remainder of those amendments is what the bill sponsor was requesting. We are leaving that, and I think the way it is stated, with artificial light, even though it's saying it needs to be a color, even though it's not visibly a color, it's still a color because it is artificial.

**Senator Schaible:** Do we need to add a 'must' to line 12 of the Christmas tree version?

**Scott Peterson, Deputy Director, Game and Fish:** Our only concern about the version we last saw was in the line 19, the sentence starts 'the artificial light...' it was amended to read 'may' we would like 'must' reinstated. If that is done, we have no objection to the bill.

**Chair Unruh:** That's the little change that I've got in the amendments here. The 'must' would remain. I think the rest of the 'mays' are ok, it was just the one with the artificial light must produce a red, green, or amber color when used in the hunting of coyote or fox.

Senator Cook: Page 1, line 17, an individual 'may' or must, which is it?

**Chair Unruh:** May. When talking about an individual, we want to use 'may,' when talking about an artificial light, and the color it produces, we need to use 'must.' The rest of the amendments are okay.

**Senator Schaible:** I move to adopt the amendment ending in .02001, with the change on line 17 that leaves the artificial light 'must.'

HB 1412 Testimony to the House Energy and Natural Resources Committee Representative Todd Porter, Chairman Coteau Room A, 2:30 PM, 1 January 2019

Mr. Chairman and Committee members.

For the record, I am Representative Bill Tveit, I serve District 33, which is all of Mercer and Oliver Counties as well as the northern and western parts of Morton County.

I am here to present HB 1412, A BILL for an Act to create and enact a new section to chapter 20.1-01 of the North Dakota Century Code, relating to hunting predators; and to amend and reenact section

20.1-01-08 of the North Dakota Century Code, relating to hunting predators at night with artificial light, digital night vision, thermal vision, or infrared light.

HB 1412 is a constituent driven bill. This bill helps to aid farmers and ranchers in protecting their investments in the production of livestock and poultry on their premises.

Line 12 simply adds the use of new technology of <u>lighting and vision</u> to the law. Line 13 and throughout the measure, <u>person</u> is changed to mean individual or individuals.

On Line 14, the words, <u>owl and rabbit</u> were removed due to the protection of the owl and the non aggressive nature of rabbits.

Line 15 and into 16 removes the word <u>"bird" and the need for action from the predator</u>, leaving the intent to mean "present on premises" as line 13 & 14 indicates.

Section 2, page 1, lines 20-24 and page 2, lines 1-5 is a new section.

This section allows a landowner/ lease holder/renters, to pursue predators with the aid of an assistant, both individuals with or without a license, to pursue and shoot specified predatory animals any time

EXCEPT September 1 thru the last day of the regular deer season.

This bill is about individuals protecting property and livelihood for our farmers and ranchers in this great state.

I would ask that you give this a unanimous great bill a"Do Pass"

# House Energy and Natural Resources Committee Testimony on HB 1412

North Dakota Game and Fish Department Stephanie Tucker, Game Management Section Leader January 31, 2019

Chairman Porter and members of the House Energy and Natural Resources Committee, my name is Stephanie Tucker and I'm the Game Management Section Leader and Furbearer Biologist of the North Dakota Game and Fish Department. I am testifying today on HB 1412.

We have had a night hunting season for coyote and fox since 1991, that typically begins after the deer gun season ends and runs through mid-March, encompassing most of the prime fur season for these two species. More recently in 2016, we began allowing the use of night vision and thermal imaging equipment during the night hunting season for coyote and fox. Currently, night hunting of coyote and fox as allowed via proclamation does not have detrimental impacts to the long-term sustainability of these populations.

We have concerns with this bill because it appears to do much more than simply allowing landowners and predator hunters to take advantage of these new night hunting technologies for a few select species.

This bill proposes expanding night hunting from just coyote and fox during the prime fur season, to any predatory animal during 9 months of the year with no other reason than it being on their property. 'Predatory animal' is not defined in state law, but when considering furbearing species that are predators, it could include bobcats, mountain lions, swift fox, fishers, marten, and river otters. These species cannot withstand unlimited night hunting during 9 months of the year, as it could decimate their populations.

This bill would also allow landowners, or 'another individual,' to take any predatory animal on their property with or without a license. Current law (20.1-03-04) allows a landowner to take furbearers on their property (during open seasons) without a license, but not another individual. Current law (20.1-07-04) also provides flexibility for landowners who wish to remove depredating or problem furbearers using methods that are outside of our normal hunting or trapping seasons. However, this bill does much more than that by allowing indiscriminate taking of predators by anyone on more than 90% of the land in North Dakota for three-fourths of the year. We believe our mandate to ensure long-term sustainability of many valuable furbearer populations would be in jeopardy if this bill were to become law.

For these reasons Chairman Porter, the Department respectfully requests a DO NOT PASS on HB 1412.

20.1-01-08. Hunting with artificial light prohibited – Exception.

It is unlawful for an individual to pursue, shoot, kill, take or attempt to take any wildlife between sunset of one day and sunrise of the next, with the aid of a spotlight or any other artificial light. This section does not make it unlawful for an individual, or their agent, to use a lantern, spotlight, digital night vision, thermal vision, infrared light, or other artificial light to assist the individual in pursuing and shooting on the individual's premises any coyote, fox, skunk, mink, raccoon, beaver, weasel, rabbit, or other predatory animal attacking and attempting to destroy the person's poultry, livestock, or other property. It is permissible to use an artificial light, digital night vision, thermal vision, infrared light with a power source of not more than six volts while hunting afoot for coyote, fox, raccoon or beaver during the open season on the animal. The artificial light must produce a red, green, or amber color when used in the hunting of coyote, fox, raccoon or beaver, except when taking a raccoon treed or at bay.

Madam Chair and committee, I wish I could say, "This ends my testimony", but, following my presentation to the House Energy & Natural Resources Committee, there was an effort made to blend HB 1412 and a like bill SB 2058 into one bill. In that cutting, pasting and negotiation, errors were made.

"must", needs to be changed to "may", as infrared does not produce a light to have color.

Madam Chair, realizing that the minor amendment above would, no doubt require this bill to go back to the House and end up in Conference Committee, I would ask that you consider a further amendment that would change the "must" to "may", and take HB 1412 back closer to the original bill that my constituent and I presented to, and left in House Energy and Natural Resources and also closer to the original intent of the authors of SB 2058.

For your consideration, Madam Chair and Committee, I do have that amendment with me, to include the Christmas Tree version.



Senator Unruh,

Our association and the fur hunting and trapping community are asking for your support of the included amendments to Engrossed House Bill 1412. As you know, we began the session with Senator Howard Anderson and Representative Don Longmuir introducing Senate Bill 2058. With your help, Senate Bill 2058 passed the Senate in January. The bills intent was to provide a measure of safety for this outdoor activity.

I have been told that Senate Bill 2058 will be used for other legislation and House Bill 1412 will move ahead in the legislative process. If this is incorrect, please let me know. The amendments (in red) to the attached Engrossed House Bill 1412 will produce the same results and are needed for these reasons:

- 1. Include the amended Section 20.1-05-04 in the Engrossed House Bill 1412 so these two Century Code sections do not compete or conflict with one another;
- 2. Strike any reference to the word "digital" when referring to night vision equipment. While many scope-like night vision optics are digital, not all are nor are the monocular and binocular night vision devices. "Digital" is much too specific, limits the use of available night vision equipment, and basically paints ourselves into a corner. The Governor's Proclamation describes the allowed equipment as "night vision", which can easily be mirrored in the Century Code.
- 3. Utilizing two paragraphs (lines 10 through 15 of page 1) will reduce the potential for confusion between what is allowed on an individual's premises (paragraph 1), and hunting afoot during the open season for the animal (paragraph 2); and
- 4. The amendments to Section 20.1-05-04 on page 2 simply duplicate the language used in the amendments to Section 20.1-01-08 on page 1.

It is my hope that you support this information and make the necessary amendments. If there is anything you need me to do or you have any questions, please let me know. Thank you again for your service to North Dakota.
