 on land for which the department pays in lieu of tax payments.
- 12 <u>A nonresident with a valid small game hunting license may hunt pheasant during the</u>
 13 <u>first seven days of the pheasant season if:</u>
- 14 a. The nonresident is an individual participating landowner whose ewns property is
