Good day Chairman Koppelman and fellow committee members.

For the record I am Jeff Magrum Representing District 28 in your state House of Representatives.

I stand before you to introduce HB1256. This bill looks simple but as you will hear it is most likely one of the most important bills of the session.

The first part of the bill is a prohibition on state and political subdivisions from soliciting or accepting any grants or donations from private persons for elections operations or administration. This issue came to light after this last election as we found out that Mark Zuckerburg's organization granted over 400 million dollars to counties nationwide and also granted to 42 counties in the state of ND to be used for elections. This is alarming considering the potential for fraud in our elections. There are strings attached to this money and I understand that the counties that received funds have to fill out forms that describe how the funds were spent. Ironically there have been reports of voter fraud throughout the nation. Mark Zuckerburg is the founder of facebook and facebook sells campaign adds as well as controlling the algorithm which means that facebook controls who sees the ads and how many times. Not only is this a conflict of interest it does create an avenue for mischief. Elections are a sacred right and the integrity of the elections should be protected at all costs. Our state is fully capable of conducting safe and fair elections without giving up our sovereignty.

The second part of the bill is a prohibition on the Governor of ND from endorsing or making political contributions directly or indirectly to a candidate for an office of the Legislative Assembly. This is based on Article five section 10 of the ND State Constitution. I will refer to the handout to explain my points further.

In closing, remember that we have three separate branches of government to keep a checks and balance on each branch of our government. There should always be a healthy tension between the branches. I pray that this doesn't happen to another candidate for the legislature. Please help to get this fixed.



Mr Chairman and members of the House Government and Veterans Affairs Committee,

My name is Andrew Bornemann. I live on a small farm near Kintyre, ND, with my wife and two young sons. Along with helping on our family farm, and running an agriculture service business, I am also currently serving as the Chairman for the District 28 Republican Party.

I am here today to speak in favor of House Bill 1256. I would like to take this time to address section 2 of this bill specifically, and to share with you why I feel this legislation is necessary.

As I am sure you all know, this last election cycle was a rather bumpy one, to put it mildly. Not only was campaigning more difficult because of the Covid-19 situation, but it was also compounded by the involvement of our sitting Governor in numerous races across the state. It is an established fact that our current Governor expended upwards of \$2 MILLION dollars of his own money in an effort to defeat specific incumbant candidates for the legislature and for statewide office; almost, if not all of whom had in some fashion opposed his pet projects or proposals in the prior election cycle.

In our district, the Governor, through his Political Action Committee, spent a significant sum on mail advertising, banners, billboards, and direct voter contact, in an effort to get his preferred candidate elected to this body. This effort was in direct opposition to the will of the people in our district, expressed through the district endorsing process, in which the candidate the Governor was campaigning against won the endorsement on the first round, and with the most number of votes, and the Governor's candidate did not receive the endorsement of the district at all. Nonetheless, the Governors PAC doubled down and increased their spending in an attempt to beat the district endorsed candidate in the primary election. This action on the part of the Governor cost our district added time and expense in making sure our voters knew who the endorsed candidates of the District Party were, and dispelling much of the misinformation that was being spread. The voters of our district thankfully rejected the Governor's assault on our choice of representatives, and proudly reelected Senator Erbele, and representatives Brandenburg and Magrum.

But what does this all matter anyway? I submit to you that the Governors actions, being involved to this extent in attempting to influence the people's choices for members of the legislature, and using the influence of his office, and his money, to target specifically persons who were contrary to his agenda in the previous session, amounts to a blatant assault on the Separation of Powers, and is a direct violation of the North Dakota State Constitution. I would like to read to you a portion of Article V, Section 10 of our Constitution:

"A governor who asks, receives, or agrees to receive any bribe upon any understanding that the governor's official opinion, judgment, or action shall be influenced thereby, or who gives or offers, or promises the governor's official influence in consideration that any member of the legislative assembly shall give the member's official vote or influence on any particular side of any question or matter upon which the member may be required to act in the member's official capacity, or who menaces any member by the threatened use of the governor's veto power, or who offers or promises any member that the governor will appoint any particular person or persons to any office created or thereafter to be created, in consideration that any member shall give the member's official vote or influence on any matter pending or thereafter to be introduced into either house of the legislative assembly, or who threatens any member that the governor will remove any person or persons from office or position with intent in any manner to influence the action of that member, must be punished in the manner now, or that may hereafter be, provided by law, and upon conviction thereof forfeits all right to hold or exercise any office of trust or honor in this state."

To me, it would seem that the Governor's use of his influence and money, in a wholesale attempt to unseat the members of the legislature who opposed his positions, constitutes a threat to ALL members of this body with removal from their seats, if they are to oppose any of his interests in the future.

On separation of powers, Gerald VandeWalle, Chief Justice of the North Dakota Supreme Court, in his State of the Judiciary Address to a joint session of the ND Legislature on January 5<sup>th</sup>, 2011, had this to say:

"We learned early in our civics courses about separation of powers in the United States. The matter was debated by the founding fathers and is enshrined in our form of government at the federal and state level. The opinions of the Supreme Court recognize "that the creation of three branches of government by our constitution operates as an apportionment of the different classes of power whereby there is an implied exclusion of each branch from the exercise of the functions of the others." State ex rel. Spaeth v. Meier, 403 N.W.2d 392, 395 (N.D. 1987). That separation of powers was implied in our State Constitution, but in 1982 the Constitution was amended to provide: "The legislative, executive, and judicial branches are co-equal branches of government." N.D. Const. art. XI, § 26. For our government to operate as it was intended, it is necessary that each branch respect the powers of the other two branches; but it is also necessary for each branch to defend its own powers against encroachment by the other two branches. The delineation of authority among the branches is not always well defined and may cause grinding and grating among the branches as each branch exercises its powers. That grinding and grating on occasion results in dissension among two or more of the branches, another lesson we learned in our civics courses.

What we did not always appreciate in our studies was that, notwithstanding the necessity of one branch of government to defend its powers against infringement by the other branches, the branches are dependent upon one another in order to fully exercise their powers. Indeed, that is part of the genius of our government and the reason that one branch is unable to govern without the assistance of other branches. In North Dakota this is the time—when the Legislature is in session—these precepts may be most apparent."

It is my opinion that HB 1256 is necessary to the deliniation of the Separation of Powers, and it is in keeping with the intent and text of the ND State Constitution. I would appreciate your support and your recommendation of a "Do Pass" on this bill as written. I would be happy to answer any questions you may have.

# Testimony on House Bill 1256 House Government and Veterans Affairs Loren DeWitz 2:00 PM, January 21, 2021

Chairman Kasper and members of the House Government and Veteran Affairs Committee, my name is Loren DeWitz. Currently I serve as District 8 Republican Party Chairman.

I have been involved in elections on the local, district, and statewide levels since the early 1970's. One observation that I have made is that years ago campaigning was on a much more personal level. Campaigning was accomplished by going door to door, using local newspaper ads, some radio and attending many community events such as church dinners, pancake suppers, parades, and auction sales, where-ever people gathered. Also, many community and county organization held forums for candidates to tell voters what they would like to accomplish. With that much personal contact, campaigns stayed on a more positive level.

In the past ten to fifteen years, we have seen a movement toward more use of Radio, TV, mail-out cards and social media. We have lost much of the personal contact. These types of campaigns tend to be more expensive and we see that those with the most money generally prevail. We have seen state-wide issues funded by people from outside of ND being successful. I don't think that the trend toward big money winning elections is good for North Dakota.

I believe that now is the time to start the discussion on this issue. Can it continue unchecked? Or do we look at some type of limits. These are not going to be easy decisions to make, but I hope there can be some discussions on this issue.

I support the concept behind HB 1256.

RE: HB 1256 – Prohibition on the use of private funds for elections and restrictions on Governor

**Section 1** of this bill adds a new section to Chapter 16.1-01 of the North Dakota Century Code prohibiting state and political subdivisions from soliciting, accepting, or using money from private persons for the administration of elections. This bill may have been prompted because the owner of Facebook offered \$350,000,000 in election administration grants to states and counties before the 2020 general election.

The Secretary of State's office did not apply for a grant because we thought it proper to only fund the state's elections with appropriated state and federal funds approved by the legislature. We also did not apply for the grant because we were informed that if we used the grant money for a social media campaign, Facebook would reserve the right to control the state's messaging to educate the voters of North Dakota through their social media platform.

It is our understanding that 47 of the state's 53 counties did apply and accept the offered grants. The Secretary of State and election team members were not asked, nor did we advise whether they should accept the funds. It was solely a county decision.

Generally speaking, we think private funds should not be used to administer elections. However, there might be exceptions. During the 2020 election cycle, Anheuser-Busch, working with the National Association of Secretaries of State, offered hand sanitizer to each state. Ultimately we did not accept the offer because of the added cost and logistics necessary to ship the correct amounts to the 53 counties.

**Section 2** prohibits a governor from endorsing or making contributions to a legislative candidate. This is contrary to the First Amendment of the United States Constitution, which guarantees the right of free speech to everyone. The United States Supreme Court has also ruled that the use of money to support or oppose an individual's bid for election is a form of free speech. The most famous case was Citizens United.

On behalf of the Secretary of State and his election team, I request the committee to give this bill in its current form a do not pass recommendation.
