For the record, I am Stephanie Dassinger. I am appearing on behalf of the North Dakota League of Cities. I am the deputy director and attorney for the League.

The North Dakota League of Cities appears in opposition to HB 1331.

This bill relates to initiating and referring ordinances. Initiating an ordinance is creating a new ordinance through a petition and a public vote and referring an ordinance is requiring a public vote on an existing ordinance. Section 2 of HB 1331 repeals section 40-12-01 of the North Dakota Century Code. That section of code provides that only cities operating under the commission or the modern council form of government may use the procedures under NDCC ch. 40-12 on the initiating or referring an ordinance. In North Dakota, cities can operate under the commission, modern council and council forms of government. Thus, NDCC ch. 40-12 on initiating and referring ordinances is not effective in cities operating under the council form of government.

However, NDCC ch. 40-12 is not the only place where the right to refer or initiate an ordinance arises from. Every home rule charter I have reviewed includes the right to initiate or refer an ordinance. On my last review of cities that have enacted home rule charters, out of the 357 cities in North Dakota, 145 cities' citizens have passed a home rule charter. To break that down further, based on the 2010 Census numbers, all cities with a population over 1,000 have enacted home rule charters. 42 cities out of the 45 with a population between 500-999 have enacted home rule charters, 26 cities out of 40 with a population of 250-499 have enacted home rule charters and 28 cities out of 223 with a population under 250 have enacted home rule charters. So, really, this bill only really affects the small cities. At the end of my testimony, I've included a list of the council cities that have not adopted a home rule charter and included their population as counted in the 2010 Census so that you know which cities this bill would impact.

Under NDCC § 40-12-02, a new ordinance can be initiated in a city by a petition signed by a number equal to 15% of the qualified electors who voted for all candidates for executive officer at the last regular city election. In order to understand what this means, I'm going to use a large sized non-home rule city, a medium sized non-home rule city and a small sized non-home rule city to demonstrate how many signatures are needed.

Under NDCC § 40-12-08, an ordinance passed by a city governing body may be referred for a vote by filing a petition with signatures from electors equal to ten percent of all the votes cast for candidates for executive officer. Using the same cities, here is how many signatures would be required.

When looking at the number of signatures required to initiate or refer an ordinance, it becomes clear that with only a household or a few households in the city, every ordinance the city has, passes, or has not considered could be put to a vote at a city election.

Finally, all city residents have available a solution of recalling city elected officials if they are unhappy with the way a city is being governed. The signature threshold is higher at twenty five percent; however, those numbers are still not very high as demonstrated with the same cities below.
