

- 11 AT&T has been a great partner to work with thus far, brainstorming unique solutions such as
- replacing our northwestern stadium light pole with a modified pole that houses both the field
- lights as well as the cellular antenna. On the back of this page is a potential rendering of what the

- Given the substantial capital investment required to ensure proper operations, AT&T has voiced
- hesitancy with the limitation of a one-year lease, as specified in 15.1-09-33 (7), to move this
- project forward. Without an adjustment allowing a longer-term lease, it is unlikely we will be
- able to finalize an agreement.
- 19 HB 1370 would provide regulatory certainty that allows the private sector to make crucial
- 20 emergency communications improvements in our community while adding value to the school
- 21 district.



- public safety community. But current law at NDCC 15.1-09-33(7) currently limits the leasing of
- school board property to one year, which is problematic given the substantial capital investment
- 18 required to ensure proper operations. AT&T has voiced concern with the current limitation in
- 19 law to make such a substantial investment.
- 20 This bill would allow school districts to have the flexibility to lease modern telecommunications
- 21 infrastructure, which is good for our students, our communities, and our public safety partners.
- 22 HB 1370 would provide regulatory certainty that allows the private sector to make important
- 23 emergency communications improvements in our community while adding value to the school
- 24 district.
