TESTIMONY OF

Sergeant Wade Kadrmas

Good morning, Chairman Ruby and members of the House Transportation Committee, my name is Wade Kadrmas, and I am the Safety and Education Officer for the North Dakota Highway Patrol. I am here today on behalf of my agency in support of House Bill 1325, which focuses on traffic violations relating to intersections.

The Highway Patrol is in support of this bill because the current fee for most moving violations dates back to at least 1973, during the 43rd Legislative Assembly. That year, the legislature passed Senate Bill 2033, the link is to the legislative history for the bill showing the \$20 moving fine. It can be found in Chapter 301 under section 6. If the legislature felt at that time that \$20 was an adequate deterrent to encourage drivers to drive safely and obey traffic laws; then \$20 today won't even come close to the monetary value of \$20 in 1973. A \$20 bill today is only worth about \$3.32 in 1973. If we took \$20 from 1973 and applied it to fines, at what it is worth today; a person could pay for six of the violations listed in this bill. Back then, the \$20 must have served as a deterrent, today that deterrent has lost its value.

Many people cite points are a bigger deterrent because points can affect insurance rates. Currently, none of the listed violations are required to be reported to insurance companies if an insurance company requests a person's driving record. In addition, points can be removed by taking an insurance point reduction course; and there is a possibility to not even have points assigned to a driving record for violations of 5 points or less.

During this ongoing debate, there is often discussion that traffic fees may be considered a tax or punishment on North Dakota citizens. Keep in mind, these fees are only assessed to individuals who commit violations of state or city traffic laws. Members of the public, who choose to responsibly obey the traffic laws, won't ever see these fees. The violations listed in this bill are related to hundreds, if not thousands, of crashes each year that cause property damage, injuries, and fatalities across North Dakota. I have no doubt that increasing fees for these moving violations will act as a deterrent to the vast majority of drivers on our roadways like it was intended to do in 1973.

Another point of discussion when the topic of speeding fines is discussed involves where collected fees go. Under section two of article nine in the <u>North Dakota Constitution</u>, relating to trust lands, it states "net proceeds of all fines for violation of state laws and all other sums which may be added by law, must be faithfully used and applied each year for the benefit of the common schools of the state". <u>Click here to view the 2019-2021 North Dakota Trust Lands Biennial Report.</u>

North Dakota Century Code (NDCC) determines where fines for city ordinances are deposited. Under NDCC 40-11-13, relating to fines and forfeitures for violation of ordinances paid into treasury, says, "All fines, penalties, and forfeitures collected for offenses against the ordinances of a city, including those fines, penalties, and forfeitures collected as a result of a judgment of a district court rendered pursuant to section 40-18-19, must be paid into the city's treasury at such time and in such manner as may be prescribed by ordinance."

That concludes my testimony in support of HB 1325, and I would be happy to answer any questions.

Additional Information:

North Dakota Point System

- Driving privileges are suspended upon an accumulation of 12 points.
- For each point over 11 accumulated, driving privileges are suspended for a period of 7 days.
- Drivers under the age of 18 have their licensed canceled upon an accumulation of 6 points.
- One point is removed every 90 days of violation-free driving.
- Three points can be reduced if a driver takes an approved defensive driving course, which can only be done once every 12 months.
- Drivers issued a citation with a penalty of five points or less may elect to attend an approved driving course in lieu of entry of points on their driving record. The driver must notify the court at the time they post their bond and provide proof of course completion to NDDOT within 30 days.
- Insurance companies are provided records of violations assigned 3 points or more unless the driver signs a waiver for the insurance company to view their entire driving record.
- The spreadsheet below includes a list of points for various violations. If the violation isn't listed, then there is no point assigned to that violation. The spreadsheet is a list of the violations in HB 1325 and the number of citations that were processed through district court in the past 5 years (2017-2021).

- 561,246 licensed ND drivers
- Approximately 132,551 suspended ND non-commercial licensed drivers.
- Approximately 2,400 suspended ND CDL licensed drivers.

For the record, I am Stephanie Dassinger Engebretson. I am appearing on behalf of the Chiefs of Police Association of North Dakota. I am also the deputy director and attorney for the North Dakota League of Cities.

The Chiefs of Police appear today in support of HB 1325. The bill increases the penalty to \$40 for intersection related violations. With the exception of a stop sign violations, the penalty for intersections has not been raised since 1973. In 2019, the Legislature passed a bill that raises the penalty for stop sign violations to \$40. HB 1325 would move all intersection violations to \$40.

When you look at the data related to intersections and crashes it becomes quite obvious that we need to do everything we can to try to change behavior at intersections.


From 2017 to 2021 there were 72,483 crashes and 25,327 of those crashes occurred at an intersection. In other words, just over one-third of the crashes occurred at intersections. However, if you dig down into the types of crashes, from 2017 to 2021 there were a total of 107 fatality crashes in North Dakota. All 107 of those fatality crashes occurred at intersections.

One issue that always comes up when we talk about traffic fines is that in 2019, the Legislature decided to give cities the discretion to double the fines for moving violations. In other words, cities can increase the fine for running a red light from \$20 to \$40. Antidotally, we know that generally there is denser traffic in our cities and that traffic violations are more likely to result in a crash. This discretion to double fines is also justified by the data.

As I stated earlier, from 2017 to 2021 there were 72,483 crashes in North Dakota. 64,566 of those crashes were in cities. In other words, just over 89% of the crashes from 2017 to 2021 occurred in cities. Further, of the total 25,327 intersection crashes in North Dakota, 22,680 of those intersection crashes occurred in cities. In other words, 89% of the intersection crashes in North Dakota occurred in cities.

In order to try to deter traffic violations at intersections and decrease crashes in North Dakota, the Chiefs of Police Association of North Dakota respectfully requests a DO PASS recommendation.

HB 1325 – Right of Way Offenses

Chairman Dan Ruby and Members of the House Transportation Committee,

Good morning, Mr. Chairman and members of the committee. My name is Corey Mock and I'm a Representative from District 18 in Grand Forks, as well as the prime sponsor for House Bill 1325.

Understanding there are many new(er) members of this committee, this bill is what experienced legislators may call "an old friend." With this committee's diligent work and commitment to public safety, I hope this bill represents one final time – at least for a generation – we need to review traffic fines.

Admittedly, HB 1325 is not as broad as it could be. You'll be met with a cooperative and supportive bill sponsor if you're inspired to expand this measure's scope.

How did we get to now?

Highways and bridges have been interwoven in the fabric of our legislature since statehood. Between 1889 and 1945, our legislature sent road and traffic bills to a Highways & Bridges Committee. A consolidated ansportation Committee" was born in 1947 and remains one of our most established standing committees.

Our traffic laws underwent a significant rewrite in 1973 – creating a foundation of fines and ordinances which will be celebrating their 50th anniversary this summer.

At the risk of oversimplification: violations of state law or municipal ordinance are either criminal (infractions, misdemeanors, and felonies) or noncriminal (monetary fine.) Most traffic violations became noncriminal offenses with the 1973 statutory rewrite.

Traffic ordinances are generally categorized as moving or non-moving violations. Members of this committee likely understand the importance of those distinctions; further elaboration is unnecessary for the purposes of this bill. There are some traffic related noncriminal violations that are neither moving nor non-moving.

Beginning in 1973, noncriminal traffic offenses were assigned a fine based on the type of violation:

Nonmoving violation: \$10

Moving violation: \$20

Careless driving: \$30

Today, the general rule for fines associated with moving and nonmoving violations is \$20, unless otherwise specified.

Attached to my testimony is a spreadsheet that quantifies the number of various offenses and the categorized fee associated with each violation. This chart does not include any speeding or overweight fines, as those vary with each offense.

Why go through all this history and context for a relatively simple bill?

As a governing body, understanding the large picture is critical when making even small adjustments to law. HB 1325 is a modest update that aligns fines for each "right of way" moving violation and makes them (mostly) consistent across the board. And with this context, my hope is the committee lays a new foundation that will someday become a new standard for traffic violations and enforcement.

State law currently contains 18 right of way violations:

\$20 fine - 12

\$40 fine - 3

\$50 fine - 2

Criminal infraction with variable fine - 1

In 2019, this committee increased the penalty of running a stop / yield sign from \$20 to \$40. The bill sponsor iginally sought a fine of \$100, but some felt that size of an increase was excessive.

Little discussion was made regarding other similar offenses. With the passage of HB 1327 in 2019, running a stop sign carries a \$40 fine while running a red light is only a \$20 citation. These are the modest inconsistencies HB 1325 hopes to address.

Could more be done to adjust the standard fine for moving and nonmoving traffic offenses? Presumably yes, and I know comprehensive adjustments would be met with broad support. And I offer my complete assistance should the committee choose to expand the scope of this bill.

HB 1325 is a modest adjustment that aligns similar violations with the penalties we enhanced four years ago. Experts and public safety professionals will speak to the human cost these violations — specifically, right of way violations — can have. And that, Mr. Chairman, is the underlying reason why I'm here today.

Thank you for your work, expertise, and creativity. I'm hopeful our discussion and subsequent efforts will be marked as a watershed moment in traffic safety... one that is celebrated and lauded over the next 50 years.



Chairman Ruby and Representatives of the House Transportation,

My name is Jeff Solemsaas, I'm here to voice our support for HB 1325. This bill would increase the fees assigned to right of way violations. This bill is strongly supported by the Bismarck Police Department

I have been a law enforcement officer for almost 30 years, for the last 10 I have been assigned as the Traffic Commander for the City of Bismarck Police Department. Currently we investigate approximately 3000 traffic collisions each year. A large portion of those collisions involve a right of way violation. By increasing the fees associated with these violations you are providing a deterrent for drivers to exercise care and caution while driving.

The attitude among many drivers is that traffic violations are not important and that violations carry no real penalty. Many drivers have the mentality that if they are caught by law enforcement for a violation there is no effect other that a minor fee. I have spoken with numerous drivers that have reported that they feel the chances of getting caught are minimal and if they are the penalties are even smaller. It should be noted that the fees assigned to traffic violations have not changed in the last 50 years.

There is no benefit to law enforcement from the enhanced penalties as none of the funds received from traffic violations are distributed to law enforcement. Bismarck has an ordinance that requires all fees from traffic violations be distributed to the general fund. The most important factor to consider is that you are providing a deterrent to bad driving. If the fees associated with traffic violations had some type of effect on drivers, they may choose to drive with more caution to avoid a financial consequence.

Any law enforcement officer would be able to relate a story in which they have stopped a driver for another state for a traffic violation. Upon receiving the citation and having the consequences explained the common response is disbelief that the fees are so low. I have had numerous encounters with drivers from other states that have laughed at the extremely low fees.

In other sessions other legislators have made comments that they know they are safer drivers when they leave ND due to the fact that they want to avoid traffic citations. I frequently receive complaints from citizens relating to traffic violations in the community. The most common statement I receive is that "you have to raise the fees for these violations". I always explain to them that they need to contact their legislators. I'm quite certain they never do.

I appreciate your consideration and time relating to this bill.

- 3. No personAn individual operating a vehicle may not exit from any position within a roundabout without first giving a signal of intention to exit the roundabout.
- 4. An individual may not stop or suddenly decrease the speed of a vehicle without first giving an appropriate signal in the manner provided herein to the driver of any vehicle immediately to the rear when there is opportunity to give such signal.
- 4.5. The signals required on vehicles by subsection 2 of section 39-10-39 may not be flashed on one side only on a disabled vehicle, flashed as a courtesy or "do pass" signal to operators of other vehicles approaching from the rear, nor be flashed on one side only of a parked vehicle except as may be necessary for compliance with this section."

 - b. If a city establishes an ordinance with a fee exceeding the limit for an equivalent category of violation as set forth in section 39-06.1-06, the city, at least annually, shall submit to the state treasurer for deposit into the state tuition fund a payment of the total amount collected.
- 3. For every violation of a city ordinance enforcing the requirements of title 40, Code of Federal Regulations, section 403 relating to publicly owned treatment works, or prohibiting shoplifting, vandalism, criminal mischief, or malicious mischief, the penalty may not exceed a fine of one thousand five hundred dollars, imprisonment for thirty days, or both such fine and imprisonment.
- 4. This section does not prohibit the use of the sentencing alternatives, other than a fine or imprisonment, provided by section 12.1-32-02 for the violation of a city ordinance, nor does this section limit the use of deferred or suspended sentences under subsections 3 and 4 of section 12.1-32-02."

For the record, I am Stephanie Dassinger Engebretson. I am appearing on behalf of the Chiefs of Police Association of North Dakota. I am also the deputy director and attorney for the North Dakota League of Cities.

The Chiefs of Police appear today in opposition of HB 1325. In its initial form, HB 1325 only increased the penalty to \$40 for right of way related violations and the Chiefs of Police supported the bill. The House Transportation Committee added sections 1 and 3 to the bill which take away a city's ability to increase traffic fines by 100 percent.

Except for stop sign violations, the penalty for right of way violations has not been raised since 1973. In 2019, the North Dakota Legislature passed a bill that raised the penalty for stop sign violations to \$40. HB 1325 would increase the penalty for all right of way violations to \$40. The right of way violation that the Chiefs of Police are most concerned about are stop light violations. The current statewide penalty for a red light violation is \$20. Some cities have raised that penalty to \$40.

As mentioned earlier, sections 1 and 3 remove a cities' ability to double traffic fines; however, the denser traffic in our cities increases the likelihood for traffic violations occurring resulting in a crash. The crash data supports giving cities the authority to double traffic fines in cities.

From 2017 to 2021 there were 72,483 crashes in North Dakota. 64,566 of those crashes were in cities. In other words, just over 89% of the crashes from 2017 to 2021 occurred in cities.

The Chiefs of Police respectfully request that you amend the bill to remove sections 1 and 3, leaving a city's ability to double traffic fines in law. Further, the Chiefs of Police are open to amending section 2 to only address red light violations to narrowly tailor the bill to the problem the Chiefs most want to address.
