"SECTION 2. AMENDMENT. Subsection 7 of section 57-38-30.3 of the North Dakota Century Code is amended and reenacted as follows:

- A taxpayer filing a return under this section is entitled to the following tax credits:

 - b. Renaissance zone tax credits under sections 40-63-04, 40-63-06, and 40-63-07.
 - c. Agricultural business investment tax credit under section 57-38.6-03.
 - Seed capital investment tax credit under section 57-38.5-03.
 - e. Planned gift tax credit under section 57-38-01.21.
 - Biodiesel fuel or green diesel fuel tax credits under sections 57-38-01.22 and 57-38-01.23.
 - g. Internship employment tax credit under section 57-38-01.24.
 - h. Workforce recruitment credit under section 57-38-01.25.
 - Marriage penalty credit under section 57-38-01.28.
 - j. Research and experimental expenditures under section 57-38-30.5.
 - k-j. Geothermal energy device installation credit under section 57-38-01.8.
 - Long-term care partnership plan premiums income tax credit under section 57-38-29.3.
- m.l. Employer tax credit for salary and related retirement plan contributions of mobilized employees under section 57-38-01.31.

- n.m. Income tax credit for passthrough entity contributions to private education institutions under section 57-38-01.7.
- e.n. Angel investor tax credit under section 57-38-01.26.
- p.o. Income tax credit for employment of individuals with developmental disabilities or severe mental illness under section 57-38-01.16.
- q.p. Adoption tax credit under section 57-38-01.38.
- F.q. Tax credit for contributions to a maternity home, child-placing agency, or pregnancy help center under section 57-38-01.39.
- s.r. Apprenticeship tax credit under section 57-38-01.40.
- t.s. Twenty-first century manufacturing and animal agricultural workforce incentive under section 57-38-01.41.
