

2 Testimony in Support

Chairman Elkin and members of the Senate Education Committee. For the record my name is Dr. Michael McNeff – I serve as the superintendent of schools in Rugby, ND. I come to you today to provide some feedback on SB 2070, a bill related to teaching permits. I and many other superintendents have taken advantage of 15.1-18-10 of the North Dakota Century Code. I am in support of the changes made within SB 2070. We have found success in filling classrooms with quality individuals that may lack the proper licensure to teach in North Dakota. This part of Code is set to sunset later this year on July 31, 2023.

I hope to provide some examples of why I feel this legislation is needed going forward. First and foremost, we have been able to maintain a quality art program at Rugby High School. Over the past three years, we have used alternate ways to maintain this program. We hired an excellent teacher that had a higher education background in the arts and through some recent legislative changes he was able to obtain licensure. We were able to keep that person for two years and he retired last year. We spent most of the spring and summer looking for an art teacher. Fortunately, we were able to look internally and promoted a paraeducator that will finish up his art illustration degree soon. This person was able to obtain a permit due to his vast background in art and he qualified due to his 4,000 hours of documented work in the art field. He has all of the intangibles and what it takes to be an effective teacher without the traditional background. This opportunity has now encouraged him to seek a career in education. He will be completing is bachelor's in art illustration and he is interested in entering a master's program in art education.

Expanding the sunset clause to 2031 and providing additional time to enroll and complete a traditional teaching program is a great way to get people into the field and keep them there. There are plenty of nontraditional people that would make excellent teachers. SB 2070 provides flexibility while still maintaining high standards. Without this additional flexibility, we would not have been able to provide an art program for our 300 students at Rugby High School.

Testimony SB 2070 Senate Education Committee January 10, 2023; 10:00 A.M. Education Standards and Practice Board Dr. Rebecca Pitkin

Good morning, Chairman Elkin, and members of the Senate Education Committee. My name is Rebecca Pitkin, and I am the Executive Director of the Education Standards and Practices Board. I am here today in support of SB 2070 and to provide information about the permit bill which became law during the 66th legislative session (HB 1531). Most of the language in SB 2070 is the same, and the bill allows individuals without a 4-year degree, who have expertise in certain content areas, excluding the areas in line 21, to be the teacher of record per district request showing individuals have the qualifications on page 2, lines 1-6. The intent of the original bill was to provide relief for the teacher shortage in non-core areas until July 2023, and during that time to collect feedback on the bill's success, impact on the teacher shortage, and its ability to motivate some individuals to enter the field of teaching as a regularly trained teacher. The original bill has been in effect for 4 years. This year there have been more permits issued to new candidates than year two and three combined.

Attached to this testimony is a list of individuals who have received a permit and it is evident there are a variety of content areas represented. Students were able to have classes they may not otherwise been able to given a districts inability to find a teacher. A total of 46 positions have been filled because of this opportunity.

The following information details the outcomes of permit holders during the first three years of the original bill:

1. 35% of year 1, 2, and 3 individuals are still on a permit license

- 2. 24% of Permit holders have become licensed regularly
- 3. 24% are no longer licensed
- 4. 10% moved to a sub license to continue involvement in schools but could no longer hold a permit.
- 5. 7% of individuals ran out of time, having used the 3-year allowed by law

Qualitative comments gathered the past 4 years have provided information on the strengths of those with a permit including: knowledge of the content, positive relationships with students, ability to bring the outside world into the classroom, experience in their field, excellent work ethic, internal motivation, they are members of the community members where they now teach, and some were prevoiusly a paraprofessional in the building. Reported challenges include classroom management, managing time within a class period, and lesson planning. For this reason, line 5 on page 2 requires individuals with a permit to enroll in the Teacher Support System mentoring program so they can receive support in needed areas.

Survey responses collected in March 2022 provided evidence administrators who employed individuals with a permit recommended continuation of this bill in some format to allow a permit as a solution to the shortage. Section 6 of SB 2070 states individuals who are not enrolled in a teacher education program have a maximum of 3 years on a permit; those who enroll in a teacher education program can remain on a permit up to six years to complete their teacher education degree.

The ESPB board supports HB 2070 and the changes proposed are those developed by a subcommittee of our board. This concludes my testimony, and I will gladly answer any questions.

Chairman Elkin, Vice-Chairman Beard and Members of the Senate Education Committee:

For the record I am Senator David Rust of District 2. I'm here to introduce SB 2070.

During the 2019 Legislative Session HB 1351 was passed that created a teaching "permit." It was the first time such a term was used in licensing or certifying teachers. And, it was to be issued in only noncore teaching areas.

Its intent was to give school boards the option to hire a "community expert" to teach if a qualified teacher couldn't be obtained.

HB 1351 was a stop-gap bill allowing a school board to hire someone for <u>one</u> year, up to a maximum of 3 years, if certain conditions were met.

It was never intended to be a permanent solution, and for good reason—students deserve to be taught by qualified, certified teachers. One of the fears of the passage of HB 1351 was that the quality of education and the resulting knowledge students would receive would be significantly diminished with this option.

A number of school districts have used teaching permits to temporarily fill a vacant teaching position. However, per the provisions of the bill, 15.1-18-10 sunsets on July 31, 2023.

SB 2070 does the following:

- 1. Extends the sunset to July 31, 2031. (See p. 1 line 7 and p. 2 line 22)
- 2. Adds a pathway for those who want to teach after those first three years. Those wishing to continue in the teaching

profession may need more time to complete their teaching degree. Hence, P. 1 lines 16-18 adds the provision that "the board of a school district may authorize the individual to teach for an additional three years, up to a maximum of six years, if the individual also is enrolled in a teacher education program."

I've asked Dr. Pitkin of the ESPB to come here today to provide you with information on the individuals and schools who have utilized teaching permits, to explain the bill further and to answer any questions you may have.

That concludes my testimony. I'll remain for a bit to answer any questions you may have.

The original bill has been in effect for 4 years. This year there have been more permits issued to new candidates than year two and three combined.

Attached to this testimony is a list of individuals who have received a permit and it is evident there are a variety of content areas represented. Students were able to have classes they may not otherwise been able to, given a district's inability to find a teacher. A total of 46 positions have been filled because of this opportunity.

The following information details the outcomes of permit holders during the first three years of the original bill:

- 1. 35% of year 1, 2, and 3 individuals are still on a permit license
- 2. 24% of permit holders have become licensed regularly

- 3. 24% are no longer licensed
- 4. 10% moved to a sub license to continue involvement in schools but could no longer hold a permit.
- 5. 7% of individuals ran out of time, having used the 3-year allowed by law

Qualitative comments gathered the past 4 years have provided information on the strengths of those with a permit including: knowledge of the content, positive relationships with students, ability to bring the outside world into the classroom, experience in their field, excellent work ethic, internal motivation, they are members of the community members where they now teach, and some were previously a paraprofessional in the building. Reported challenges include: classroom management, managing time within a class period, and lesson planning. For this reason, page 2 on line 5 requires individuals with a permit to enroll in the Teacher Support System first year teacher mentoring program to receive support in needed areas.

Survey responses collected in March 2022 provided evidence administrators who employed individuals with a permit recommend continuation of this bill in some format to allow a permit as a solution to the shortage. Section 6 of SB 2070 states individuals who are not enrolled in a teacher education program have a maximum of 3 years on a permit; those who enroll in a teacher education program can remain on a permit up to seven years to complete their teacher education degree.

The ESPB board supports HB 2070 and the changes proposed are those developed by a subcommittee of our board, as well as amendment by the Senate Education Committee. This concludes my testimony, and I will gladly answer any questions.

SB 2070 Introduction to House Education Committee David S. Rust, Senator District 2

Chairman Heinert, Vice-Chairman Schreiber-Beck and Members of the House Education Committee:

For the record I am Senator David Rust of District 2. I'm here to introduce SB 2070.

During the 2019 Legislative Session HB 1351 was passed that created a teaching "permit." It was the first time such a term was used in licensing or certifying teachers. And, it was to be issued in only noncore teaching areas.

Its intent was to give school boards the option to hire a "community expert" to teach if a qualified teacher couldn't be obtained.

HB 1351 was a stop-gap bill allowing a school board to hire someone for <u>one</u> year, up to a maximum of <u>three</u> years, if certain conditions were met.

It was never intended to be a permanent solution, and for good reason—students deserve to be taught by qualified, certified teachers. One of the fears of the passage of HB 1351 was that the quality of education and the resulting knowledge students would receive would be significantly diminished with this option.

A number of school districts have used teaching permits to temporarily fill a vacant teaching position. However, per the provisions of the bill, 15.1-18-10 sunsets on July 31, 2023.

SB 2070 does the following:

- 1. Extends the sunset to July 31, 2031. (See p. 1 line 7 and p. 2 line 22)
- 2. Adds a pathway for those who want to teach after those first four years. Those wishing to continue in the teaching profession may need more time to complete their teaching degree. Hence, P. 2 lines 16-18 adds the provision that "the board of a school district may authorize the individual to teach for an additional four years, up to a maximum seven years, if the individual also is enrolled in a teacher education program."

I've asked Dr. Pitkin of the ESPB to come here today to provide you with information on the individuals and schools who have utilized teaching permits, to explain the bill further and to answer any questions you may have.

The bill has been a success as we already have individuals who have obtained a degree and are contracted to teach; we have individuals with a teaching permit who are in a program to become a teacher, and those who are in their first year.

It is definitely an option for school districts that are unable to presently fill a vacant position, giving them time to either find a qualified teacher or possibly have one for the future.
