#### BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

For a raffle board, an organization permitted to conduct raffles shall sell the numbered squares on the board for the same price and may sell squares at a site thirty days before the drawing.

3. A licensed distributor shall affix a North Dakota gaming stamp to each deal of pull tabs, raffle board, punchboard, sports pool board, calcutta board, and series of paddlewheel ticket cards sold or otherwise provided to a licensed organization or organization that has a permit and shall purchase the stamps from the attorney general for thirty-five cents each. Ten cents of each stamp sold by the attorney general, up to thirty-six thousand dollars per biennium, must be credited to the attorney general's operating fund to defray the costs of issuing and administering the gaming stamps. If an organization hosts an event with a raffle board and only sells numbered squares on the event, the organization is exempt from the requirements under this subsection."



Madam Chair and committee members,

For the record, my name is Senator Conley from District 12.

SB 2126 is a bill to allow charitable organizations to sell numbered squares on raffle boards at a site 30 days before the day of the drawing (rather than on the day of the drawing as NDAC 99-01.3-05-01 currently allows). Common practice has been that raffle boards have been sold many days prior to the drawing but now the gaming commission has decided to enforce this administrative rule creating a hardship for those trying to raise funds for their communities.

# Senate Finance and Taxation Senate Bill No. 2126 Relating to the Sale of Raffle Board Squares January 16, 2023, Fort Totten Room

During the 2019 session the requirement of a permitted organization to have a state gaming stamp on a raffle board was removed from statute. This was to make it less expensive and easier for a permitted organization to conduct a raffle board. This requirement was removed since it was determined that since the squares on the raffle board were sold and the drawing held onsite at the event then just having the site authorization was enough to regulate that the games of chance being conducted were approved.

Should you accept this activity the Office of Attorney General would respectively request that an amendment be made to require a state gaming stamp once again on raffle boards for the permitted organizations to ensure citizens when purchasing a square on the raffle board that the game has been authorized by the state and local governing body.

A licensed distributor shall affix a North Dakota gaming stamp to each deal of pull tabs, raffle board, punchboard, sports pool board, calcutta board, and series of paddlewheel ticket cards sold or otherwise provided to a licensed organization or organization that has a permit and shall purchase the stamps from the attorney general for thirty-five cents each. Ten cents of each stamp sold by the attorney general, up to thirty-six thousand.

North Dakota laws and rules allow several variations on the conduct of a raffle.

Raffle ticket sales — where a player may purchase a raffle ticket for a drawing to be held at a future date. It is a two part ticket where the stub to be placed in a receptacle has pertinent information on the player so that the player can be contacted should they win. The other part of the ticket is given to the player as a receipt of the purchase and gives the player pertinent information regarding the place and time of the raffle and prizes to be won. Last session it was also approved that licensed organizations may sell tickets online and accept electronic payment.

Calendar Raffle – is a raffle in which a player's ticket stub is entered in two or more drawings held on predetermined days over an extended period of time for predetermined prizes. The player again receives a receipt of the purchase that gives the player pertinent information regarding the raffle.

Raffle Board – is a board on which numbered squares must be sold for the same price at a site on the day of the drawing. The organization completes the board with the cost per square and prizes. For each square sold, an employee writes the player's full name on the square purchased and duplicate numbers corresponding to the numbered squares on the board must be placed into a receptacle for drawing.

Double Roll Ticket – this is a raffle where two single tickets are printed side by side on a roll with a consecutive number. Both tickets must have the same number. A double roll raffle must also be conducted on the same day of the event.

Electronic fifty-fifty raffles – can be conducted either by manual drawing or by using a random number generator. Fifty-fifty raffle tickets must be sold and drawings held onsite at the location of and on the date of the event.

# Testimony of Dana Hager Economic Development Association of North Dakota In Support of SB 2306 March 3, 2023

Chair Longmuir and members of the House Political Subdivisions Committee:

My name is Dana Hager, executive director of the Economic Development Association of North Dakota (EDND). I want to express our support for SB 2306 regarding Job Development Authorities (JDA).

EDND represents more than 80 state economic development organizations on the front line of economic development efforts throughout North Dakota. The organization's primary purpose is to promote the creation of new wealth throughout North Dakota to develop more vibrant and efficient communities and improve quality of life. Many of our members are governed through the JDA chapter of Century Code to "encourage and assist in the development of employment and promotion of tourism within the county."

The new subsection proposed in SB 2306 does not impact or change the way a county JDA currently operates but allows for more flexibility in establishing strong and invested boards for JDAs. This change will streamline the process for our communities and create more efficiencies and better communication between EDOs and JDAs. EDND supports steps to help strengthen our organizations who working hard for North Dakota at the local level.

Thank you for the time and energy to discuss SB 2306. EDND urges a Do Pass.

Chairman Longmuir and members of the committee, for the record, I am Senator Conley from District 12 in Jamestown. Currently, Administrative Rule NDAC 99-01.3-05-01 states that raffle board sales can only take place on the day of the drawing. SB 2126 is a bill to extend sales from 1 day to 30 days before the drawing.

Raffle boards are often used in small communities to raise funds for charitable causes such as providing assistance to a family in need or to raise funds for the local rural fire department.

Common practice has been to sell squares on the board and then close the raffle when the board is full. In small communities it is just not possible to sell out the board in 1 day, which ends up limiting the amount of funds raised for good community causes.

SB 2126 passed the Senate on a 44-3 vote and I am asking for a favorable recommendation.

North Dakota laws and rules allow several variations on the conduct of a raffle.

Raffle ticket sales – where a player may purchase a raffle ticket for a drawing to be held at a future date. It is a two-part ticket where the stub is placed in a receptacle and has pertinent information about the player so that the player can be contacted should they win or if there is an issue with the raffle. The other part of the ticket is given to the player as a receipt of the purchase and gives the player pertinent information regarding the place and time of the raffle and prize(s) to be won.

For each square sold, an employee writes the player's full name on the square purchased and duplicate numbers corresponding to the numbered squares on the board must be placed into a receptacle for drawing.

Double Roll Ticket – this is a raffle where two single tickets are printed side by side on a roll with a consecutive number. Both tickets must have the same number. A double roll raffle must also be conducted on the same day of the event.

Electronic fifty-fifty raffles – can be conducted either by manual drawing or by using a random number generator. Fifty-fifty raffle tickets must be sold and drawings held onsite at the location of and on the date of the event.

During the 2019 session the requirement of a permitted organization to have a state gaming stamp on a raffle board was removed from statute. This was to make it less expensive and easier for a permitted organization to conduct a raffle board. This requirement was removed since it was determined that since the squares on the raffle board were sold and the drawing held onsite at the event then just having the site authorization was enough to regulate that the games of chance being conducted were approved.

Should this bill pass the Office of Attorney General Gaming Division questions the safety and security of the conduct of selling squares on a raffle board over a period of time. There is no way for an organization to contact a player and a player would not have a receipt of purchase with information concerning the raffle.

A licensed distributor shall affix a North Dakota gaming stamp to each deal of pull tabs, raffle board, punchboard, sports pool board, calcutta board, and series of paddlewheel ticket cards sold or otherwise provided to a licensed organization or organization that has a permit and shall purchase the stamps from the attorney general for thirty-five cents each. Ten cents of each stamp sold by the attorney general, up to thirty-six thousand.
