Madam Chair Lee and honorable members of the Senate Human Services Committee. My name is Mark Jorritsma and I am the Executive Director of North Dakota Family Alliance Legislative Action. We are submitting testimony in support of Senate Bill 2230 and respectfully request that you issue a "DO PASS" on this bill.

With the overturn of Roe v. Wade earlier this year and the likely upholding of our state's Trigger Law on abortions, expectant mothers will be seeking options other than abortion to address their circumstances. That's where adoption can come in. If as a state, we were the ones to make abortions illegal through our laws, it seems appropriate for us to come alongside these new mothers and help them with alternatives to abortion like adoption.

One way to do this is by helping families looking to adopt. Adoption costs can be substantial, so if there is a way for the State of North Dakota to help facilitate the process, all the better. Testimony of Jean Nasers Interim Director of Christian Adoption Services

Before the North Dakota Senate Committee on Human Services on SB 2230

SUPPORT January 23, 2023

Thank you, Ms. Chairperson, and members of the Committee for providing the opportunity to submit written testimony in support of Senate Bill 2230. My name is Jean Nasers, and I am the interim director for Christian Adoption Services.

I am a wife and the biological mother of three children. One night my youngest son woke up in the middle of the night because of teething. As I held him close, my eyes filled with tears as I thought of all the moms that long to hold a baby in their arms. The next morning, my daughter and I giggled over a shared inside joke. A tinge of sorrow struck my heart as I thought of the silence so many parents experience during breakfast. That same day, I watched my husband play catch with our oldest son. I thought of all the amazing dads that would love to share one of these moments.

I share this with you because for the last four years I have walked with numerous families as they go through the adoption process. I speak with anywhere between 5-10 families in North Dakota a month interested in growing their family through domestic adoption. The desire of all of their hearts is the same: to provide for and love a child(ren), to be a family. The majority of families that seek to grow their family through adoption have been impacted by infertility and have already had a long, draining journey. They have gone through a good deal of emotional, spiritual, mental, and physical hardship in the hope of growing their family. Not all but many have spent a considerable amount of time and money on fertility treatments and/or surgery just for a chance to have a child. After thinking for a considerable amount of time, a family will decide that adoption is the best (and likely only) option for them to pursue to become parents, so they reach out to an adoption agency.

In North Dakota, the cost to for domestic infant adoption is approximately \$25,000 from beginning to end. These costs typically cover application, orientation, home study, expectant parenting counseling, placement costs, and all the travel required to successfully complete an adoptive placement. Many families have to resort to taking out a personal loan in order to cover the costs associated with adoption because payment plans are not an option because services are provided immediately. Some of the costs associated with the adoption process vary from case to case; however, every adoptive family must complete a home study in order to adopt. The cost for a home study is approximately \$4,000. The home study cost is a small portion of the entire cost of an adoption, but the home study is the most important and essential part of the adoption process because it is the part of the process that determines if a family is safe and healthy to adoption a child.

Currently, there is minimal assistance to help cover the cost of adoption for families. The time has arrived for North Dakota to provide support to these families by helping cover the cost of home studies. The funding provided by this bill would allow us to support families up front in the adoption process. If honored with the full amount of funds requested, my agency would use the funds completely for home studies and to offset the cost of adoption for adoptive families in North Dakota.

Please support Senate Bill 2230 so we can increase the support provided to adoptive families throughout North Dakota. Thank you for the opportunity to submit written testimony.

My name is Mark Jorritsma and I am the Executive Director of North Dakota Family Alliance Legislative Action. We are submitting testimony in support of Senate Bill 2230 and respectfully request that you issue a "DO PASS" on this bill.

With the overturn of Roe v. Wade last year and the likely upholding of our state's Trigger Law on abortions, expectant mothers will be seeking options other than abortion to address their circumstances. That's where adoption can come in. If as a state, we were the ones to make abortions illegal through our laws, it seems appropriate for us to come alongside these new mothers and help them with alternatives to abortion like adoption.

One way to do this is by helping families looking to adopt. Adoption costs can be substantial, so if there is a way for the State of North Dakota to help facilitate the process, all the better. Also, with the total possible outlay associated with this bill being capped at \$250,000, it mitigates the potential financial impact if adoptions post-Roe dramatically increase in North Dakota.

For the aforementioned reasons, North Dakota Family Alliance Legislative Action asks that you issue a "DO PASS" recommendation on SB 2230. With that, I'd be happy to stand for any questions.

Good Afternoon Chairman Weisz and Members of the Committee,

Thank you for your time and consideration of my testimony.

I am testifying in support of SB 2230 in my capacity as an adoptive mother and Cass County, ND resident.

My sons, now 5 and 3 years old, were born out-of-state but adopted into our family as infants while we lived in West Fargo. Adopting them into our family has been the greatest blessing of our lives.

Prior to their adoptions, we went through the home study process twice, once in 2016 and once in 2018. The cost of the home study did not exceed \$5,000 but was labor and time intensive. It included gathering financial statements, personal interviews with the local adoption agency case worker, a psychological assessment, home inspection completed by the agency caseworker, and educational readings.

I support this bill because it supports the building of health families by reducing the financial burden of an already time-intensive process. Passage of this bill would reduce the financial burden for ND families hoping to adopt or families considering adoption who may not otherwise be able to afford it. This bill also indirectly supports mothers and fathers making adoption plans as well as indirectly supports the child being placed into a loving adoptive family.

The only improvements I would suggest would be the following:

1. In Section 1 lines 11-12 regarding eligibility and exclusions: My hope is that all ND families desiring to adopt would be eligible to have costs covered upon the completion of the process. I do not believe income should be a factor, for example. There are many other costs to adoption besides the home study process, and it remains expensive even for families with high incomes due to

placement costs, as families usually cover the entire cost of the agency's work on behalf of the expectant families in addition to the agency's work on behalf of the adopting family, since adoption counseling and placement services are generally free to expecting parents. The total cost of adoption to our family after paying for home study costs, adoption agency time and fees, attorney fees, travel and lodging was more than 10 times the cost of the home study alone.

2. In Section 1 lines 11-12 regarding eligibility and exclusions: Ensure that families choosing to work with any agency — secular or religious — are eligible. Our family worked with a Christian agency, and we would not want to be restricted from this program and/or have the agency restricted based on its, or our, religious beliefs.

Thank you so much for all you do and for your consideration of my testimony. Your work as lawmakers and civic leaders is truly appreciated.

I would like to start off by saying thank you for your consideration for this bill. If a bill like this were to be passed, it would be of substantial help in easing the financial burden to hopeful adoptive families who are pursuing adoption to grow their families.

My husband and I have unexplained infertility and decided soon after finding this out in 2017 that we would try to grow our family through adoption. Before finding out about our infertility, I hadn't ever considered adoption as I knew that the cost of it was so high. I didn't understand why it should cost families who cannot have biological children so much. When we started to look into different adoption agencies, we were surprised by the fees that we were facing. We decided to move forward anyways and to apply for grants to aid in helping us to pay for the fees. Since then, we have been blessed to have added two children to our family through adoption.

We are currently thinking about entering into the adoption process for a third adoption. If this bill were to be passed, it would not be a benefit to our family, but to many other families in North Dakota who are going through the adoption process. Thank you again for your consideration of this bill. I asked that you would consider voting in favor of this bill and providing much needed assistance to many hopeful adoptive families.



I AM DAVID CLEMENS AND REPRESENT DISTRICT 16 IN THE SENATE. I AM HERE TO INTRODUCE SB 2230.

SB 2230 IS RELATING TO ESTABLISHING AN ADOPTION ASSISTANCE PROGRAM FOR COSTS ASSOCAITED WITH THE HOME STUDY PROCESS.

THE DEPARTMENT SHALL ESTABLISH AN ADOPTON ASSISTANCE PROGRAM TO PROVIDE FINANCIAL ASSISTANCE FOR ADOPTIVE FAMILIES.
