Thank you for the opportunity to submit testimony on Senate Bill No. 2242. My name is Matt Perdue, and I am testifying on behalf of North Dakota Farmers Union's (NDFU) members.

NDFU supports SB 2242, which would establish a propane storage tank revolving loan fund at BND. This program would help retailers expand propane storage, which is important to North Dakota farmers. During the busy harvest season, farmers rely on propane for drying corn and other crops. Shortages of propane can slow harvest progress, creating serious economic costs for North Dakota producers. Increasing propane storage will help retailers pre-position adequate supplies to handle seasonal demand spikes.

NDFU respectfully requests a "Do Pass" recommendation on SB 2242. Thank you for your consideration.

Chairman Patten and Members of the Committee:

For the record, my name is Mike Rud. I serve as the Executive Director of the North Dakota Propane Gas Association. On behalf of over 130 NDPGA members and the well over 1,000 North Dakotans they employ, we thank Senator Erbele for introducing this bill and urge a "DO PASS" recommendation on SB 2242.

# ALL OF THE ABOVE ENERGY POLICY. That's been ND's goal from Day One!

In my role as an Empower ND commissioner for over a decade, this has been the mantra. The strategic partnerships being formed between North Dakota's long-standing and emerging energy industries enable all energy sectors to work together to meet state and national needs.

Propane is certainly part of that energy makeup. It's been a reliable energy source in North Dakota for nearly 100 years. The State currently has about 50,000 homes, farms and businesses using safe, efficient and affordable propane. Many of NDPGA's locally owned and operated businesses likely serve your communities in some capacity.

SB 2242 will go a long way towards helping ND propane retailers in enhancing services to well over 300 rural communities and hundreds of ag producers the industry currently serves today. While the loan pool will be administered by the Bank of North Dakota, the loans will be secured from private banks across the state, meaning the monies will stay in local communities and close to home.

Passage of SB 2242 means retailers can potentially put 6-8 Million more gallons of storage capacity on the ground across the state in the next few years. That's good news for energy security in ND and very good news in the long run for state consumers. This low interest loan program will allow retailers to access the cash needed at very affordable interest rates at a key time in the industry's history.

NDPGA members are on hand today to present a very strong case for passage of this bill. These retailers will cover the changes the industry has experienced over the last decade due to pipeline supply issues as well as share a more in-depth cost analysis study relating to the proposed low interest loan program for retail propane storage.

I Thank you for your time and consideration regarding this important energy issue. I urge a "DO PASS" recommendation on SB 2242.



# Testimony SB 2242 Senate Energy & Natural Resources Committee- February 2, 2023

Chairman Patten and Members of the Energy and Natural Resources Committee:

For the record, my name is Jarett Schatz. I would like to start by saying thank you to the committee for allowing me to speak on behalf of my propane company Tri-N Propane out of Minot. I also serve on the Board of Directors of the North Dakota Propane Gas Association. I appear today asking for a "DO PASS" recommendation on SB 2242.

NDPGA has been studying and working towards some type of low interest loan program for enhancing retail storage for over a year now. Our propane committee has worked many hours getting this bill put together for this legislative session. I wish to thank Senator Erbele and all the bill sponsors for working with NDPGA. I also want to thank the Bank of ND and those NDPGA members who served on the propane storage bill committee for drafting sound language.

A "DO PASS" recommendation on this bill would mean a lot to many propane retailers in the state. It would allow propane marketers to have more product on hand in times of peak demand like prolonged stretches of cold weather and the grain drying season.

This bill as written calls for 50 million dollars of low interest revolving loan pool money using the (SIIF) Strategic Investment and Improvement Fund for the purpose of enhancing propane storage capacity for our state marketers. BND would administer the loan program. It allows a maximum loan of 500,000 dollars per marketer with 15% down payment from a retailer. The loan would carry a 2% interest rate with a 15 year payback period. These loan guidelines will help us retain capital and save money on interest payments. That is huge for a small company like mine in a market where we have some of the tightest margins in the country as the graphs from the Energy Information Administration I have supplied in my testimony point out.

If you would refer to the cost analysis graph in my testimony, you can see pricing and cost comparison for different sized storage vessels I worked up with a regional vendor. A propane retailer could add up to (3) 30,000 gallon tanks to current bulk storage facility with the passage of SB 2242. Three 30,000 gallon tanks would be \$538,350 with 15% down \$80752.50 loan value would be \$457,597.50 for a quick scenario.

My company would be one of the first in line to secure funding from this bill. It will greatly reduce logistic problems as well as storage shortfall. Most importantly, it would offer marketers and our customers piece of mind that we will have the propane on hand for their growing needs. Personally, my business would be looking to borrow around \$300,000 to put in (2) 30,000 gallon tanks.



In closing I would like to again say thank you for allowing me the time to be a part of this great process while trying to stay ahead of industry issues for the state of North Dakota and its residents.



I am currently the National Propane Gas Association State Director for North Dakota. I also serve on the Board of Directors for the North Dakota Propane Gas Association. I appear today asking for a "DO PASS" recommendation on SB 2242.

Since the Cochin Pipeline was removed from service in April of 2014, ND has been short product. This shortage has been due to storage capacity and product flow. The Cochin pipeline used to supply 900,000 gallons of storage and would receive and disperse over 60,000 gallons per day. This loan would help marketers replace the supply that we lost. It would also help in times of need due to the extra storage capacity.


Although we have the Bakken Oilfield in Western ND, most of that product is either railed or piped out of state to storage caverns and facilities across the United States. It is even shipped overseas. We do not have the storage capacity to hold onto the gas here in our own state.

In the past month, we have hauled over 40% of our loads from Canadian facilities to North Dakota and Montana. As a state that has the resources to supply our own product, this makes no sense. A storage facility would greatly impact the amount of gas we could keep right here in ND.


We, as a company, would not be purchasing storage under this bill. However, we would be hauling product to and from these facilities. Any extra storage capacity takes a huge weight off our shoulders and others in times of peak demand. It allows for proactive planning prior to long stretches of subzero weather or wet harvesting conditions, rather than reactive emergency waivers due to supply issues and long lines at terminals.


### North Dakota Gas Plants Propane Output



U.S. Customs and Border Patrol ports of entry for propane shipments on Cochin pipeline











### Without the Cochin pipeline, western Canadian propane seeks new outlets



In April 2014, after 35 years of shipping propane from western Canada to the upper Midwest, the <u>Cochin pipeline</u> was removed from propane service, and in July repurposed to ship light petroleum liquids north <u>from Illinois to western Canada</u>. Without this pipeline, western Canadian propane production has been shipped by other existing transport modes or placed into inventory at Canadian storage facilities. Recently, the declining value of western Canadian propane has encouraged the development of projects to provide additional outlets for growing production.


Prior to its removal from propane service, the Cochin pipeline provided an effective outlet for western Canadian propane production. EIA tracks imports of propane by port of entry. Historically, propane imported from Canada on the Cochin pipeline had been reported at one of three border crossings into North Dakota: Portal, Northgate, and Sherwood. Imported propane on Cochin likely makes up most of the product reported at these locations. In 2013 and early 2014, propane imports at these three border crossings surpassed 60,000 barrels per day (bbl/d) in times of high demand for propane during winter heating or crop-drying seasons. The substantially diminished flows, approximately 10,000 bbl/d since April 2014, are assumed to be propane shipments by rail or truck.

With decreased Canadian propane exports to the Midwest (as defined by Petroleum Administration for Defense District 2), there has been a rise in the use of the existing capacity of Canadian storage facilities. Western Canadian inventories at the start of March 2015 were more than six times higher than March 2014 levels, and eastern Canadian inventories were more than three times March 2014 levels, and more than double the five-year average.


Canadian propane exports to the United States at other border crossings, where rail is the primary mode of transport, reached a record 37,600 bbl/d in December 2014. Propane has also been shipped out of western Canada in pipelines that carry a mixture of propane with other hydrocarbons; the mix is later processed to separate propane. For instance, propane mixed with other hydrocarbon gas liquids (HGL) is shipped out on the Enbridge pipeline system, and propane mixed with natural gas and other HGL is shipped out on the Alliance pipeline.

Note: Western Canada inventories include underground storage in Alberta and Saskatchewan; Eastern Canada inventories include underground caverns in southern Ontario.

Higher utilization of existing storage and transportation capacity, coupled with increased propane production from shale gas plays in the United States, has placed downward pressure on Canadian propane prices. Before the 2013-14 winter, spot propane prices in Edmonton, berta, regularly traded at about \$0.12/gallon below those in Conway, Kansas. This price difference generally reflected the cost of apping propane by pipeline between the western Canadian and Midwestern markets. During the 2013-14 winter, prices at both locations were above \$2.00/gallon at a time when high propane demand coincided with pipeline and processing facility maintenance outages and low inventory levels. Since then, Edmonton propane has sold at \$0.27/gallon below the price at Conway, reflecting the higher transportation costs in the absence of Cochin's propane-shipping capacity.



This widening price differential has prompted the development of other options for moving and using/consuming propane, including:

- A 22,000 bbl/d propane dehydrogenation (PDH) plant to process propane into propylene (an important petrochemical industry feedstock) that Williams Energy Canada plans to build in Alberta by 2018
- Four projects to build marine terminals to export liquefied petroleum gases to Asia, with potentially up to 150,000 bbl/d of capacity
- Two planned rail terminals from Keyera and Plains Midstream to provide approximately 85,000 bbl/d of additional rail capacity. The
  rail terminals would support the shipment of propane and butane to the West Coast marine terminals, Midwest markets, and Gulf
  Coast export terminals.







# Testimony SB 2242 House Energy and Natural Resource Committee March 3, 2023

Chairman Porter and Members of the Committee:

For the record, my name is Mike Rud. I serve as the Executive Director of the North Dakota Propane Gas Association.

On behalf of over 130 NDPGA members and the well over 1,000 North Dakotans they employ, we thank Senator Erbele for introducing this timely bill and urge a "DO PASS" recommendation on SB 2242.

### ALL OF THE ABOVE ENERGY POLICY. That's been ND's goal from Day One!

In my role as an Empower ND commissioner for over a decade, this has been the mantra. The strategic partnerships being formed between North Dakota's long-standing and emerging energy industries enable all energy sectors to work together to meet state and national needs.

Propane is certainly part of that energy makeup. It's been a reliable energy source in North Dakota for nearly 100 years. The State has about 50,000 homes, farms and businesses using safe, efficient and affordable propane. Many of NDPGA's locally owned and operated businesses likely serve your communities in some capacity.

Passage of SB 2242 means retailers can potentially put between 2-3 Million more gallons of storage capacity on the ground across the state in the next few years. That's good news for energy security in ND and very good news in the long run for state consumers.

This low interest loan program will allow retailers to access the cash needed at very affordable interest rates at a key time in the industry's history.

I can tell you, NDPGA surveyed its membership again over the last few weeks. The appetite remains strong amongst marketers willing to participate in the loan program. I can say confidently, 75% of the loan pool is likely already spoken for at this time if SB 2242 becomes a reality.

Bottom Line: SB 2242 will go a long way towards helping ND propane retailers in enhancing services to well over 300 rural communities and hundreds of ag producers the industry relies on and serves today.

While the loan pool will be administered by the Bank of North Dakota, the loans will be secured from private banks across the state, meaning the monies will stay in local communities and close to home. (BND officials are here to answer any questions you might have regarding the revolving loan perameters)

NDPGA members have submitted on-line testimony as well as come to the Capitol today, presenting a very strong case for passage of this bill. These testimonies cover the changes the industry has experienced over the last decade due to pipeline supply issues as well as share a more in-depth cost analysis study relating to the proposed low interest loan program for retail propane storage.

I Thank you for your time and consideration regarding this important energy issue. I urge a "DO PASS" recommendation on SB 2242.


