SB 2259

Testimony in Favor of 2259 68th session

Chair and Committee, My name is Phil Murphy representing the ND Soybean Growers Association. We are thankful to the prime sponsor and the State Auditor for the extensive discussions resulting in this bill. That both wish this to succeed speaks volumes as to why it should be approved. I believe that there is an intention to propose an amendment for an opt-out option as well, but if not I would request it. I would expect that option to apply to all, but if not, would like to explain why the NDSGA requests it for our sister organization, the ND Soybean Council, aka the NDSC. It has to do with the fact that they are the only purely Federal checkoff and have been more work for the State Auditor departments for a couple of reasons; One, the NDSC auditing standards are more stringent/different than North Dakota's and Two, instead of being audited once every two years as are other commodities, the NDSC must be audited each year. This is, another words, a longer and unfamiliar process resulting in higher costs for audits. Thank you for your kind consideration.



Testimony of Deana Wiese, Executive Director North Dakota Ethanol Council In Support of SB 2259 January 26, 2023

Chairman Luick and members of the Senate Agriculture and Veterans Affairs Committee,

For the record, my name is Deana Wiese, and I am here today as the executive director of the North Dakota Ethanol Council in support of SB 2259, which caps the audit cost for agriculture commodity groups.

The North Dakota Ethanol Council (Council) was established in 2009 by the North Dakota State Legislature to fund research, education programs, promotion, and market development efforts. The structure of the Council was modeled off those of other state agricultural check-off organizations. It is funded by the first ethanol check-off program in the nation with each plant contributing three one-hundredths of one cent per gallon of ethanol produced. The Council has an annual budget of roughly \$150,000-\$200,000, which makes it one of the smallest commodity councils based on funding.

The Council appreciates the work done by the bill sponsor and the State Auditor to bring this bill forward for discussion. The cap amount can be debated given the diverse budgets and activities of each commodity. While I don't have any immediate suggestions, I would be happy to be in on those discussions. However, more importantly, I would like to reference line 17 of the bill that establishes the agricultural commodity groups 'established in title 4.1' as those included in the intent of the bill. There are several listings of agriculture commodity groups within the agriculture title 4.1. Given this, I would respectfully recommend specifying the agriculture commodity promotion groups in 4.1-44-04, which are the ag commodity groups that must report to the House and Senate Agriculture Committees during each legislative assembly.

With this specification, the North Dakota Ethanol Council supports SB 2259. I'd be happy to answer any questions.

Senate Bill 2259

Chairman Luick, members of the Committee, my name is Lindsey Slappy. I am an audit manager for the North Dakota State Auditor's Office. I am here to testify neutrally on Senate Bill 2259 and would like to provide some additional information to clarify previous testimony. There are currently 2 commodities that receive annual financial statement audits. These two commodities are the Beef Commission and the Soybean Council. Their national organizations require them to receive an annual financial statement audit. Within this requirement, there are a couple additional items that are required to be included in the Supplementary Information of that report.

The auditing standards used to complete these audits are no different than the standards used by our office and all other auditing firms that complete government audits. All audits are completed under *Government Auditing Standards*. The financial statements are required to be prepared in accordance with pronouncements issue by the Government Auditing Standards Board referred to as the GASB. Both auditing standards and GASB standards are always changing. This can result in fluctuations in the amount of time to complete the project. This is especially true since the Auditor's Office not only audits the financial statements, but they help prepare them. A GASB change could increase preparation time as well as auditing time.

All other commodities receive what is called a special purpose financial statement audit. NDCC 4.1-44-04 states that those commodities receive an audit of a single page statement of revenues and expenditures for two fiscal years. None of the other commodities have requirements to receive an annual audit so this is how these are handled by our office.

The potential change to opt-out would also result in increased costs to the commodity groups. While the concept to cap the bills issued from the State Auditor's Office is feasible (Money goes into the General Fund), we would not have the ability to cap the fees charged by private firms. The current average bill rate used by the State Auditor's Office is \$85 dollars an hour. The average bill rate from a local firm that is contracted to complete an audit of a state agency is \$157 per hour.

All audits of state agencies are the responsibility of the State Auditor's Office under NDCC 54-10. Due to this, there would also still be time required from the state auditor's office for this change. We would still be responsible for contracting the audit with a private firm if this opt-out option was available. This would include preparing and posting a request for proposal, scoring the request for proposal, completing the contract, and reviewing the completed audit report for approval. We currently contract for all audits of state agencies completed by private firms except for entities that are not considered legally part of the State of ND. For example, Bank of North Dakota, Housing Finance, Job Service, and several others.
