FULL NOTICE OF INTENT TO ADOPT AND REPEAL ADMINISTRATIVE RULES

TAKE NOTICE that the North Dakota Department of Agriculture will hold a public hearing to address proposed new N.D. Admin. Code 7-04-05, proposed new N.D. Admin. Code 7-18, proposed amendment to N.D. Admin. Code 60-03-03-03, and the proposed repeal of N.D. Admin. Code 7-14-01 and 7-14-02 at 8:30 AM on September 13, 2021, at the Fort Lincoln Room in the State Capitol in Bismarck. The purpose of proposed rule 7-04-05 is to formalize a temporary quarantine, the purpose of proposed rule 7-18 is to implement statutes, the purpose of proposed rule 60-03-03-03 is to update an adopted reference, and the purpose of the proposed repeal is to remove the industrial hemp rules. The proposed rule 7-04-05 addresses the quarantine of moss ball plants after invasive zebra mussels were found in the plants. Proposed rule 7-18 adopts rules governing the grain warehouse inspection program that reflect changes made in the most recent legislative session. The proposed amendment to NDAC 60-03-03-03 updates the adoption of the federal worker protection standards. The proposed repeal of NDAC 7-14-01 and 7-14-02 repeals the administrative code relating to the regulation of industrial hemp.

The proposed rules, amendment and repeal are not expected to have an impact on the regulated community in excess of \$50,000. None of the proposals will result in takings. None of the proposals require a small entity economic impact statement or small entity regulatory analysis. There have been no regulatory analyses required.

The proposed rulemaking 7-18 implements house bill number 1026, enacted during the most recent legislative session, concerning the financial criteria for grain buyers, grain brokers, and grain processors; relating to the definitions grain brokers and processors, the duties and powers of the commissioner, confidentiality records, scale ticket contents, credit-sale contracts, reports, annual licenses, fees, and bonds for grain buyers, grain brokers, grain processors, and warehouseman, and to provide a penalty.

The proposed rules may be reviewed at the office of the North Dakota Department of Agriculture, 600 E. Boulevard Ave., Bismarck.
