FULL NOTICE OF INTENT TO AMEND ADMINISTRATIVE RULES

TAKE NOTICE that the North Dakota Board of Dietetic Practice will hold a public hearing to address proposed **amendments to N.D. Admin. Code 20.5-01-01, 20.5-02-01, and 20.5-02-02** at 9:00 a.m. CST on Wednesday, March 16, 2022, at <https://us02web.zoom.us/j/81276601849>. The purpose of the proposed amendments is to **implement updates to the statute licensing dietitians and nutritionists in North Dakota**. The proposed **amendments** addresses a change to NDAC 20.5-01-01 by updating the board contact information; changes to NDAC 20.5-02-01 that provide clarifications related to applications for nutritionists and licensees who supervise interns, applications for provisional licenses, requirements for renewal of lapsed licenses, changes to licensing fees, a revision of the way fees for late renewal applications are assessed, modifications of the rule related to the renewal of licenses and late fees, and clarifications related to continuing education requirements; and changes to NDAC 20.5-02-02 by providing revisions of the code of ethics and aspects of unprofessional conduct.

The proposed amendments **are not** expected to have an impact on the regulated community in excess of \$50,000.

The proposed rulemaking implements SB 2187 enacted during the most recent legislative session, concerning the licensing of dietitians and nutritionists in North Dakota.

The proposed rules may be reviewed at the office of the North Dakota Board of Dietetic Practice at 603 Foster Ave NW, Cooperstown, ND 58425.
