FULL NOTICE OF INTENT TO CREATE AND AMEND ADMINISTRATIVE RULES

TAKE NOTICE that the North Dakota Board of Medicine will hold a public hearing to address proposed amendments and a new chapter to N.D. Admin. Code title 50, at 9:00 a.m. on December 6, 2023, at the Board's Conference Room, located at 4204 Boulder Ridge Rd, Suite 220, Bismarck, ND 58503. The purpose of the proposed amendments is to implement 2023 legislative changes provided under Senate Bill 2115 and Senate Bill 2221, specifically moving physician and physician assistant licenses to a two-year renewal cycle and updating penalty fees, CME requirements, and record retention requirements and moving naturopathic doctors from the Board of Integrative Health (N.D.A.C. Article 112-02) to the Board of Medicine (N.D.A.C. Article 50-06). The proposed amendments address general board administration (article 50-01), physician licensure (article 50-02), physician assistant licensure (article 50-03), continuing medical education (article 50-04), admission to practice naturopathic medicine (chapter 50-06-01), authority of naturopaths including a formulary and endorsement for prescriptive practice (chapter 50-06-02), and continuing education (chapter 50-06-03).

The proposed amendments are not expected to have an impact on the regulated community in excess of \$50,000.

Written or oral comments on the proposed rules sent to the above address or telephone number and received by December 16, 2023, will be fully considered.
