## NOTICE OF INTENT TO AMEND ADMINISTRATIVE RULES RELATING TO N.D. ADMIN. CODE CHAPTERS 75-03-23 AND 75-03-24 PROVISION OF HOME AND COMMUNITY-BASED SERVICES UNDER THE SERVICE PAYMENTS FOR ELDERLY AND DISABLED PROGRAM AND THE MEDICAID WAIVER FOR THE AGED AND DISABLED PROGRAM AND EXPANDED SERVICE PAYMENTS FOR ELDERLY AND DISABLED

TAKE NOTICE that the North Dakota Department of Health and Human Services will hold a public hearing to address proposed amendments to N.D. Admin. Code chapters 75-03-23 and 75-03-24 at 12:30 p.m. on Thursday, September 21, 2023, in Bismarck, N.D. in Room 210, located on the second floor of the Judicial Wing of the State Capitol.

The proposed amendments to N.D. Admin. Code chapters 75-03-23 and 75-03-24, Provision of Home and Community-Based Services under the Service Payments for Elderly and Disabled Program and the Medicaid Waiver for the Aged and Disabled Program and Expanded Service Payments for Elderly and Disabled, are necessary, in part, to comply with 2023 Senate Bill No. 2012.

The proposed changes are as follows:

**Section 75-03-23-01** is amended to replace the definition of "client" with "eligible individual", and to amend the definition of "department", "Medicaid waiver program", "natural supports", "service fee", "service payment" "SPED program", and "SPED program pool".

**Section 75-03-23-03** is amended to replace "person" and "recipient" with "individual".

**Section 75-03-23-04** is amended to update language to reflect person first language.

**Section 75-03-23-05** is amended to replace "client" with "eligible individual", to update language to reflect person first language, and to add companionship services and its eligibility criteria to the list of available services.

**Section 75-03-23-06** is amended to replace "client" with "eligible individual", update language to reflect person first language, to remove attendant care as an available service under the waiver, which ended on July 1, 2023, to remove nurse assessment as an allowable service under the 1915(c) Medicaid waiver and the effective date clause, and add personal care with supervision to help eligible individuals who need supervision and help with personal care.

**Section 75-03-23-07** is amended to replace "client" with "eligible individual", to update language to reflect person first language, to require a representative of an enrolled QSP agency or an individual QSP to complete a department approved QSP orientation prior to initial enrollment, and to add language stating that agency providers who have accepted an authorization to provide 24-hour supports to an eligible individual must give a 30-day written notice before they can involuntarily discharge the eligible individual from their care.

Section 75-03-23-08 is amended to replace "client" with "eligible individual".

**Section 75-03-23-08.1** is amended to replace "recipients" with "eligible individuals" and to provide that department may terminate a QSP if the QSP has demonstrated a pattern of absenteeism by failing to provide care they have been authorized and agreed to provide to an eligible individual.

Section 75-03-23-09 is amended to replace "client" with "eligible individual".

Section 75-03-23-11 is amended to replace "client" with "eligible individual".

**Section 75-03-23-14** is amended to replace "recipient" and "client" with "eligible individual".

**Subsection 5 of section 75-03-23-15** is amended to replace "recipients" with "eligible individuals".

**Section 75-03-24-01** is amended to amend the definition of "department" and "Ex-SPED program pool".

**Subsection 1 of section 75-03-24-03** is amended to replace "person" with "individual".

**Subsection 5 of section 75-03-24-05** is amended to replace "recipients" with "eligible individuals".

**Section 75-03-24-07** is amended to replace "client" with "eligible individual", to update language to reflect person first language, and to add companionship and its eligible criteria to the list of available services.

**Section 75-03-24-09** is amended to replace "client" and "person" with "eligible individual".

Section 75-03-24-10 is amended to replace "client" with "eligible individual".

**Section 75-03-24-12** is amended to replace "recipient" with "eligible individual".

The proposed amendments are anticipated to have a positive impact on the regulated community in excess of \$50,000. No taking of real property is involved in this rulemaking action.
