NOTICE OF INTENT TO AMEND ADMINISTRATIVE RULES RELATING TO N.D. ADMIN. CODE CHAPTER 33-07-01.1 HOSPITALS

TAKE NOTICE that the North Dakota Department of Health and Human Services will hold a public hearing to address proposed amendments to N.D. Admin. Code chapter 33-07-01.1 at 1:00 p.m. on Friday, September 22, 2023, in Bismarck, N.D. in Room 210, located on the second floor of the Judicial Wing of the State Capitol.

The proposed amendments to N.D. Admin. Code chapter 33-07-01.1, Hospitals, create a new category of hospital as established by the Consolidated Appropriations Act of 2021 and in response to 2023 House Bill Nos. 1050 and 1165. Federal law does not mandate the proposed rules.

The proposed changes are as follows:

Section 33-07-01.1-01 is amended to provide that American society of addiction medicine level 3.7 substance use treatment programs licensed by department, that are independent from a medical hospital, aren't covered by medical hospital licensure laws in response to 2023 House Bill No. 1050. The section is amended to add the definition of "rural emergency hospital", to revise the definition of "department", to remove the definition of "qualified activities coordinator", and to update language.

Section 33-07-01.1-02 is amended to add a defined term to require the department to issue sperate license for building on separate premises.

Section 33-07-01.1-04 is amended to replace "person" with "individual" and to replace "his or her" with "their".

Section 33-07-01.1-08 is amended to provide that a hospital has been subjected to department's decision to initiate a ban or limitation on admissions, a suspension or revocation of a license, or denial to license, has the right to request a hearing before the office of administrative

hearing, to replace "health council" with "department" in response to 2023 House Bill No. 1165, and to replace "person" with "individual".

Section 33-07-01.1-09 is amended to remove the requirements related to when a physician assistant admits a patient, to add language specifying that rural emergency hospitals are subject to governing body requirements for primary care hospitals, and to replace "his or her" with "their".

Section 33-07-01.1-12 is amended to replace "person" with "individual".

Section 33-07-01.1-14 is amended to replace "person" with "individual".

Section 33-07-01.1-15 is amended to add language specifying that rural emergency hospitals are subject to medical staff requirements for primary care hospitals and to correct errors in the numbering of subdivisions.

Section 33-07-01.1-16 is amended to add language specifying that rural emergency hospitals are subject to nursing services requirements for primary care hospitals.

Section 33-01-01.1-19 is amended to update a reference to match the current structure of the department and to replace "person" with "individual".

Subdivision i of subsection 1 of section 33-07-01.1-20 is amended to replace "person" with "individual".

Section 33-07-01.1-23 is amended to replace "film" with "images".

Section 33-07-01.1-25 is amended to remove a requirement that sterile burn sheets be available for the provision of emergency services, to add language specifying that rural emergency hospitals are subject to emergency services requirements for primary care hospitals, and to replace "person" with "individual".

Section 33-07-01.1-32 is amended to replace "person" with "individual".

Section 33-07-01.1-33 is amended to replace "person" with "individual".

Section 33-07-01.1-34 is amended to update the reference of "mothers" to "patients".

Section 33-07-01.1-34.1 is amended to update the reference of "women" and "mother" to "patient" and to update language.

Section 33-07-01.1-36 is amended to replace "person" with "individual" or "patient" and to update the reference of "women" and "mother" to "individuals" and "parent".

The proposed amendments are not anticipated to have an impact on the regulated community in excess of \$50,000. No taking of real property is involved in this rulemaking action.
