## NOTICE OF INTENT TO AMEND ADMINISTRATIVE RULES RELATING TO N.D.A.C. CHAPTER 75-04-05 PAYMENT FOR PROVIDERS AGENCIES OF SERVICES TO INDIVIDUALS WITH INTELLECTUAL DISABILITIES - DEVELOPMENTAL DISABILITIES

TAKE NOTICE that the North Dakota Department of Human Services will hold a public hearing to address proposed amendments to N.D. Admin. Code chapter 75-04-05 at 1:00 p.m. on Thursday, September 3, 2020, in Bismarck, N.D. in Room 210, located on the second floor of the Judicial Wing of the State Capitol.

The proposed amendments to N.D. Admin. Code chapter 75-04-05, Payment for Provider Agencies of Services to Individuals with Intellectual Disabilities -Developmental Disabilities, are necessary to comply with the provisions of the 21st. Century Cures Act, Electronic Visit Verification.

The proposed changes are as follows:

**Section 75-04-05-01** is amended to update the definition of "units of service" for parenting support and in-home support from an hourly unit to a fifteen-minute unit. This change will require developmental disability providers to bill for every fifteen minutes of service rather than one hour of service.

The proposed amendments are not anticipated to have an impact on the regulated community in excess of \$50,000. No taking of real property is involved in this rulemaking action.

Copies of the proposed rules are available for review at human service zones (formerly known as county social services) offices and at human service centers. Copies of the proposed rules, the regulatory analysis relating to these rules, and the telephone call number for public access to real time streaming of the public hearing may be requested by telephoning (701) 328-2311.
