



FULL NOTICE OF INTENT TO ADOPT, AMEND, REPEAL ADMINISTRATIVE RULES

TAKE NOTICE that the Education Standards and Practices Board will hold a public hearing to address proposed amendments to N.D. Admin. The purpose of the proposed rules are to amend kindergarten through grade 12 license fee configuration, adopt a military spouse fee waiver, amend alternate access license dates, amend school psychologist intern requirements, adopt out of field endorsement requirements, adopt an educator ethics requirement, adopt national board certified teachers reeducation requirements, adopt license revocation guidelines, amend the professional skills test requirements, amend transcript language, adopt driver's education reeducation requirements, repeal the interim license for substitute teachers requirements, and general edits for clarity.

The proposed amendment is expected to have an impact on the regulated community in excess of \$50,000.

The proposed rulemaking implements bill numbers 2306 and 1531, enacted during the most recent legislative session, concerning military spouses and educator permits.
