 The Office of the Adjutant General received \$9,000,000 of federal state fiscal recovery (ARPA) funds for the construction of the Camp Grafton fitness facility through the agency's appropriation bill (SB 2016) of the Sixty-Eighth legislative assembly. Additional federal authority of \$2,000,000 for Sustainment, Restoration and Modernization funds are being requested to complete construction and provide the ability to conduct the Army's Combat Fitness Test and a designated area for cardio and weight training within the facility.

Provide an explanation as to how the request supports state priorities, improves state efficiencies, and promotes effective state government:  
 This request provides the necessary funding to complete the construction of the fitness facility located at Camp Grafton Training Center where the North Dakota National Guard trains to provide ready units, individuals, and equipment to support our communities, state, and nation. We are focused on building a premier force, that is relevant today, and evolves to meet the missions of tomorrow.



Provide any other relevant information:

The Office of the Adjutant General received \$9,000,000 in federal state fiscal recovery (ARPA) funds for the construction of the Camp Grafton fitness facility. However, based on current construction costs, the desired fitness facility for Camp Grafton would have cost over \$19,600,000. Due to funding constraints, the facility size was reduced and an additional \$2,000,000 in Sustainment, Restoration and Modernization federal funds were designated for this project. The \$11,000,000 fitness facility will provide the ability to conduct the Army's Combat Fitness Test year-round and include a designated cardio/weight training area within the facility.
