EFFECTIVE DATES OF 2007 LEGISLATION

Section 13 of Article IV of the Constitution of North Dakota and North Dakota Century Code (NDCC) Section 1-02-42 provide the rules for determining the effective dates of laws enacted by the Legislative Assembly. The general rule is that a law takes effect on August 1 after its filing with the Secretary of State. An appropriation measure for the support and maintenance of state departments and institutions or a tax measure that changes tax rates takes effect on July 1 after its filing with the Secretary of State. Later effective dates can be specified in a bill, and a law that is declared an emergency measure which passes each house by a vote of two-thirds of the members-elect of each house can take effect upon its filing with the Secretary of State.
