Representative Koppelman,

I am gathering the information you requested regarding legislative space in the Capitol. I will follow up tomorrow with sq. footage estimates for space used by the Legislative Branch. But, I believe the Legislative Council office is currently using about 11,500 sq. ft, which likely will need to increase some during the next biennium if the proposal to transfer some IT personnel from ITD to our office goes forward (the Senate Appropriations Committee has amended the Legislative Branch bill to increase our IT staff by 8 positions).

I have asked Facilities for sq. footage of the other rooms we are using. I suspect we are occupying over 10,000 sq. feet in the J-wing this session.

We have spent nearly \$3 million of CARES funding in response to COVID. Over \$700,000 was for replacement of the chamber voting boards. Most of the remaining funds were related to IT upgrades, including the audio/visual upgrades and costs for streaming the video. The cost of constructing the 4 new committee rooms, exclusive of the audio/visual costs, is likely going to be in the \$150,000 to \$200,000 range.

In calculating the \$40 million total, we went with an assumption of moving all legislative operations, other than the chambers, to the new structure which would located where the legislative parking lot now exists. There had been prior discussions regarding a structure there to include underground parking, so we used that as a starting point. We looked at 80,000 sq. feet of space plus the cost of furnishing the building. We used \$400 per sq. foot as an estimate for the construction.

There could be 2 levels of underground parking which could provide 200-250 parking spots which potentially could connect by tunnel to the existing structure. The ground floor could be used for committee rooms which would include some large hearing rooms and all rooms having added safety with multiple exits. The committee rooms could be similar in size to the rooms constructed in the J-wing.

The second level could be used for secure legislator office space and be connected to Legislative Hall by a skywalk (this could accommodate leaving a driveway between the new structure and the existing structure to allow traffic to move between the north and south sides of the Capitol).

The third level could be used to move the LC staff and include space to move in IT equipment such as servers for which we currently pay rent to ITD.

If individual legislator offices were replaced with large "studies" for each chamber with a small number of offices, maybe for committee chairmen, and a reduction in the LC space, I would think one floor could be eliminated.

In some of the informal discussions I had with John Boyle, I inquired whether other agencies could be moved into space if the Legislative Branch vacates current meeting rooms and the LC office space. He indicated there are several agencies that could move from off campus rental space. For example some of the rooms in the horseshoe could house some small one or two person entities. I suspect there could be efficiencies where some of those entities could share personnel.

CHAPTER 48-10 CAPITOL GROUNDS PLANNING COMMISSION

48-10-01. Capitol grounds planning commission.

The capitol grounds planning commission consists of the lieutenant governor as chairman and eight other members selected biennially as provided in this section. The governor shall appoint two citizens, one licensed architect, and one representative from the state historical society as members, the president of the senate shall appoint two senators as members, and the speaker of the house of representatives shall appoint two representatives as members. Appointment to the commission is for a term of two years. Legislative and citizen members of the planning commission are entitled to per diem payments and expenses in such amount and in the same manner as provided by law for members of the legislative management.

48-10-02. Capitol building fund to be administered by the capitol grounds planning commission - Continuing appropriation - Procedure for expenditure of certain funds.

The capitol grounds planning commission shall have general powers to superintend the administration of the capitol building fund, its interest and income fund, and its investments and properties. It may cause any lands now held in such funds to be sold at market value, direct the conversion of any securities now held by such funds to cash, approve expenditures from such funds subject to law and legislative appropriations, and to do all other things necessary to carry out the intent and purposes of this section. The board of university and school lands or its designee, on the commission's behalf, shall see to the investment and management of the capitol building fund and its interest and income fund and shall account to the commission concerning these funds at the commission's request.

Provided further, all moneys and other property in the capitol building fund, except as otherwise appropriated, are hereby dedicated and reserved to the exclusive purpose of the construction of an addition to the legislative wing of the state capitol building, and the capitol grounds planning commission shall take necessary steps to accumulate and conserve the money and property in the capitol building fund for such purpose.

The commission may, during any biennium, expend from the interest and income fund of the capitol building fund a sum not to exceed fifty percent of the unencumbered balance on the first day of any biennium, and such amount is hereby appropriated to the capitol grounds planning commission. The expenditure may be made, after consideration of the capitol grounds master plan, for projects or planning but may not exceed two hundred fifty thousand dollars per biennium. The expenditure may only be made upon approval by two-thirds of the total membership of the commission. The expenditure must be made upon a voucher, or vouchers, prepared by the office of management and budget at the direction of the commission.

48-10-03. Powers and duties of the commission - Authority to accept gifts - Continuing appropriation.

The capitol grounds planning commission shall confer with the state council on the arts with respect to the artistic value of monuments, memorials, or works of art to be constructed on the capitol grounds and with qualified consultants retained by it to select sites for buildings, facilities, monuments, memorials, or works of art to be constructed on the capitol grounds. The commission shall develop and modify long-term plans for the development of the capitol grounds. The commission shall approve or disapprove the basic style and exterior construction of any building, facility, monument, memorial, or work of art constructed on the capitol grounds. Except as otherwise provided by this section, the commission has exclusive authority to accept or reject gifts of any type or class of property for exterior placement on the capitol grounds or for the improvement of the exterior construction of any building or facility on the capitol grounds, including landscaping and improvements to the capitol grounds. Any gifts of money accepted pursuant to this section must be deposited in the capitol building fund and are appropriated on a continuing basis to the commission for purposes consistent with this section. No construction or placement of an item on the capitol grounds may be undertaken without the approval of the commission, unless the construction or placement is authorized by the legislative assembly. Good morning,

Attached is a spreadsheet listing the size of space used by the Legislative branch.

As I mentioned yesterday, the main portion of the Legislative Council office is over 11,000 sq. ft. That space shows up in various entries on the spreadsheet because portions of the office are separated. When all the areas we use are taken into account, it appears we are currently using at least 13,000 sq. feet.

The 3 new rooms on the 3rd floor of the J-wing are all over 2000 sq. feet. The room on the 2nd floor of the J-wing used by 2 Senate committees is nearly 1900 sq. feet. As the spreadsheet indicates, we are using 14,000 sq. feet in the J-wing. However, the only room in the J-wing we consider to be our space is the Pioneer Room. The Coteau rooms and Sheyenne River Room belong to the Judicial branch, except during sessions. The executive branch is under the assumption we will be returning the other remodeled space back after the session.

Mr. Boyle included the square footage of the office space we are using on the 18th and 14th floors as well when we calculated Capitol tower space currently being used by us.

I think Boyle mentioned this to you, but in case not — NDCC 48-10-02 provides money in the capitol building fund is "except as otherwise appropriated, are hereby dedicated and reserved to the exclusive purpose of the construction of an addition to the legislative wing of the state capitol building, and the capitol grounds planning commission shall take necessary steps to accumulate and conserve the money and property in the capitol building fund for such purpose." https://www.legis.nd.gov/cencode/t48c10.pdf#nameddest=48-10-01

The commission must be consulted before the purchase or installation of furniture or fixtures in public areas of the capitol and other buildings on the capitol grounds. The commission shall perform any other duties as may be prescribed by law.

Good morning,

Attached is a spreadsheet listing the size of space used by the Legislative branch.

As I mentioned yesterday, the main portion of the Legislative Council office is over 11,000 sq. ft. That space shows up in various entries on the spreadsheet because portions of the office are separated. When all the areas we use are taken into account, it appears we are currently using at least 13,000 sq. feet.

The 3 new rooms on the 3rd floor of the J-wing are all over 2000 sq. feet. The room on the 2nd floor of the J-wing used by 2 Senate committees is nearly 1900 sq. feet. As the spreadsheet indicates, we are using 14,000 sq. feet in the J-wing. However, the only room in the J-wing we consider to be our space is the Pioneer Room. The Coteau rooms and Sheyenne River Room belong to the Judicial branch, except during sessions. The executive branch is under the assumption we will be returning the other remodeled space back after the session.

Mr. Boyle included the square footage of the office space we are using on the 18th and 14th floors as well when we calculated Capitol tower space currently being used by us.

I think Boyle mentioned this to you, but in case not — NDCC 48-10-02 provides money in the capitol building fund is "except as otherwise appropriated, are hereby dedicated and reserved to the exclusive purpose of the construction of an addition to the legislative wing of the state capitol building, and the capitol grounds planning commission shall take necessary steps to accumulate and conserve the money and property in the capitol building fund for such purpose." https://www.legis.nd.gov/cencode/t48c10.pdf#nameddest=48-10-01
