



Davis, I am a member of the Standing Rock Sioux Tribe and a descendent of the Turtle Mountain Band of Chippewa and I am proud to serve the great state of North Dakota as the Executive Director of the North Dakota Indian Affairs Commission. As Executive Director, I serve on the Governor's Cabinet. I am joined today by staff members in presenting our testimony today. Thank you for this opportunity.

Today, I am in full support of HB 1417, as it relates to a very important partnership between the State of North Dakota and our 5 Tribal Nations. As now know Cyber security is by far one of the most important defenses we have today in North Dakota and in this country. I have witnesses firsthand the number of Cyber Security attacks brought on by other countries and hackers that have stolen resources, assets and used data as hostage for payment. As challenging as it is, I believe we here in North Dakota are fortunate that we have the best Cyber Security Agency is the Nation.

As we continue to share resources and jurisdictions with our 5 Tribal Nations, we know they the Tribes are not immune to the countless Cyber attacks daily. For example, North Dakota Public Schools located within Tribal boundaries have been hacked in various ways. We have also seen attempts to hack into Tribal accounts for Oil and Gas assets and resources.

Mr. Chairman and members of the committee I ask you today to consider in amending section 54-59-05 of the North Dakota Century Code, as it relates to the powers and duties of the information technology department. The ultimate goal here is to allow the State-IDT, to enter into Memorandums of Agreements (MOA's) or Understanding (MOU's) with our 5 Tribal Nations. If the Tribes choose to enter

into the MOA's-MOU's, these agreements would ultimately and most importantly help protect Tribal data, assets, and money.

Below are the changes to the section 54-59-05 of the North Dakota Century Code. This concludes my testimony and I'll stand for any questions.

Thank you.

- 18. Notwithstanding chapter 54 40.2, may enter a memorandum of understanding with other state, local, tribal, or territorial governments of the United States for purposes of ensuring the confidentiality, availability, and integrity of state, local, and **tribal** information systems and data, including consulting, developing cybersecurity strategy, prevention of cybersecurity incidents, and response strategies to cybersecurity incidents. The department may charge an amount equal to the cost of the services rendered by the department to all agencies that receive and expend moneys from other than the general fund.
- 19. Notwithstanding chapter 54 40.2, may enter a mutual aid agreement with other state, local, **tribal**, or territorial governments of the United States agreeing to the reciprocal exchange of resources and services for mutual benefit of the parties related to cybersecurity efforts for the purposes of responding to or mitigating active cybersecurity incidents. The department may receive in kind benefits that reduce cybersecurity risks to information technology or shall charge an amount equal to the cost of the services rendered by the department to all agencies that receive and expend moneys from other than the general fund.

**RE: House Bill 1417 - Support** 

Mr. Chairman and committee members, thank you for the opportunity to briefly express the support of counties for House Bill 1417.

County officials, like state officials, recognize the growing concerns of cybersecurity within government. While we are all linked together somehow, state and county governments are inextricably bound through the numerous shared software systems that all ride on the state backbone. One node on this backbone can, and has, affected other nodes.

Counties have the statutory authority to enter into memorandums of agreement with the State, and this legislation would clearly allow NDIT to do likewise. This, county officials believe, is a very appropriate way to approach this emerging risk to government services. By structuring the responsibilities of state and local government in this manner, NDIT and local governing boards will know, upfront, what their obligations and responsibilities will be.

County commissioners view this as a true demonstration of a partnership rather than a mandate, and therefore urge a Do Pass recommendation on House Bill 1417

Chairman Kasper and members of the House Government and Veterans Committee,

My name is Erica Thunder, and I serve as the Commissioner for the North Dakota Department of Labor and Human Rights. I am here today to speak in favor and support of HB 1417. This Bill has been long in the works and its drafters have been extremely particular in making sure its language encompasses the needs for entering into mutual aid and/or memorandums of understanding (MOU) agreements, in order to ensure cybersecurity incidents can be resolved as quickly and safely as possible.

I testify today because this Bill is exceedingly important to particularly, the Labor industry. Even a few minutes of a cyber-attack can put an entity, particularly in business, at extreme risk for loss of work and other major issues of confidential work, information, etc. This type of scenario would affect both employer and employee, along with potential entities doing business. The Department believes this risk is too great and would like to see assurance that people doing business in North Dakota do not have to worry about such instances.

We in North Dakota are extremely blessed and fortunate to have a world-renown team working in Cybersecurity under North Dakota Information Technology (ND IT), particularly with Mr. Kevin Ford as Chief Information Security Officer (CISO). I would feel highly comfortable knowing we have the option, if we would ever choose to utilize



it, to enter into MOUs with some of our partners in other states. For so many of us in Labor, our worlds have changed, many of us are working in databases solely online, instead of on paper. The protection of this Bill is highly needed.

On another personal note, I am a citizen of the MHA Nation, and I believe the language of this Bill as written, has been very well done, in the events that one of the Tribal Nations with whom we share territory with, would also suffer some type of cyber security attack. This has already happened in this State. And the breach affected North Dakota citizens who also happen to be Tribal citizens.

This Bill has been very well written, is concise, and could have a huge impact in whether we have the ability to respond to a cyber security act.

For all of these reasons, I support HB 1417 and ask for a do pass.

If I am unable to answer a specific question today, I will promptly work to provide an answer to the Committee.




