Introduction/ Support of HB1436 provided by Cindy Schreiber-Beck, District 25 Representative

Chairman Mark Owens and Committee Members:

This legislation would change subsection 1 of 15.1-21-16. Summer school courses and programs – Eligibility for payment. The summer school courses and programs for which a school district may receive payments as provided in section 15.1-27-19.

The change removes the criteria of remedial instruction in mathematics and reading for K-4 (lines 10 through 13 already allowed students in 5-8 to receive nonremedial instruction). Due to the pandemic, many students need a catch-up program, and the changes will allow those students to attend summer school to receive instruction and the districts to receive payment for those students.

In the bill:

- Line 6: remedial mathematics is removed and replaced with mathematics (for K 8)
- Line 8: remedial reading is removed and replaced with reading (for K 8)
- o Lines 10-13 are removed since the changes in lines 6 through 9 provide for the instruction
- Lines 14: & 16: unnecessary language is removed
- Line 17: due to the above changes

Section 2 is the emergency clause which would allow for this legislation, if passed by both chambers and signed by the governor, to go into effect prior to the start of 2021 summer school.

Thank you for your attention and favorable consideration of this proposed legislation.

15.1-21-16. Summer school courses and programs - Eligibility for payment. The summer school courses and programs for which a school district may receive payment as provided in section 15.1-27-19 are:

- 1. a. Remedial mathematics provided to students enrolled in any grade from kindergarten through eight;
 - b. Remedial reading provided to students enrolled in any grade from kindergarten through eight;
 - c. Beginning after the conclusion of the 2009-10 school calendar, mathematics provided to students enrolled in any grade from five through eight;
 - d. Beginning after the conclusion of the 2009-10 school calendar, reading provided to students enrolled in any grade from five through eight;
 - e. Beginning after the conclusion of the 2009-10 school calendar, science provided to students enrolled in any grade from five through eight; and
 - f. Beginning after the conclusion of the 2009-10 school calendar, social studies provided to students enrolled in any grade from five through eight; and.
 - 2. Any other high school summer courses that satisfy requirements for graduation, comprise at least as many clock-hours as courses offered during the regular school term, and comply with rules adopted by the superintendent of public instruction.

(Remedial instruction at the elementary level would be developmentally appropriate instruction in remedial reading and remedial mathematics which enables students to achieve challenging academic standards. i.e.: Remedial Reading is a highly effective short-term intervention of tutoring struggling readers in both an individualized and small group setting.)

Administrative rules for elementary summer school programs can be found in Article 67-24.

Mr. Chairman and Members of the Committee:

My name is Joe Kolosky and I am the Director of School Approval & Opportunity with the Department of Public Instruction (DPI). I am here on behalf of the department, to speak in favor of House Bill 1436 regarding to flexibility to enroll into summer school courses.

Currently, students in kindergarten through 4th grade can only enroll in public summer school courses in mathematics and reading if they fall into the "remedial" category. Remedial refers to students that are below the sixtieth percentile on a standardized test; below the sixtieth percentile on a teacher-developed test; or have a grade of C or below in the school year that just ended.

Pinning students into these areas poses the risk of missing or overlooking struggling students who may need the extra foundational instruction in mathematics and reading to enable their success. In addition, providing all students (including those who are average or above average) the extra support in the summer can prevent the "summer slide." The summer slide is a decline in reading ability and other academics during the summer months. Extensive research has

been conducted on this phenomenon, and it has been concluded that up to 20% of school-year gains in reading and up to 27% of school-year gains in mathematics can be lost during the summer. These are learning losses we cannot afford.

Lastly, with the devastation the COVID-19 pandemic has caused, it is imperative now, more than ever, that we provide our students every opportunity to participate in quality education services with the fewest number of obstacles in their way. It is especially important to provide these opportunities to our youngest learners as our public schools build the foundation of their learning.

Your colleagues in the Environment & Education House Appropriations subcommittee are considering ways to accelerate the learning recovery of our students this biennium, especially of our youngest learners. One of the options they are considering is opening up the summer school opportunities for more students. This policy in NDCC 15.1-21-16 would need to be adjusted to align with that work.

Introduction: C Schreiber-Beck District 25 Representative

This legislation would change subsection 1 of 15.1-21-16. Summer school courses and programs – Eligibility for payment. The summer school courses and program for which a school district may receive payments as provide in section 15.1-27-19.

The change removes the criteria of remedial instruction in mathematics and reading for K-4 (lines 10-13 currently allow students in 5-8 to receive nonremedial instruction). Due to the pandemic, many students need a catch-up program, and the change will allow those students to attend summer school to receive instruction and the districts to receive payment for those students.

The fiscal note estimates the cost for the 21-23 biennium at \$1.3 million for both the state and the district if there is a 5% increase in summer school participation. The state cost would need to be included in the Integrated formula payments line in HB1013.

Section 2 is the emergency clause which would allow for this legislation to go into effect prior to the start of the 2021 summer school program if passed.

Mr. Chairman and Members of the Committee:

My name is Joe Kolosky and I am the Director of School Approval & Opportunity with the Department of Public Instruction (DPI). I am here on behalf of the department, to speak in favor of House Bill 1436 regarding flexibility to enroll into summer school courses, especially at the elementary level.

Currently, students in kindergarten through 4th grade can only enroll in public summer school courses in mathematics and reading if they fall into the "remedial" category. Remedial refers to students that are below the sixtieth percentile on a standardized test; below the sixtieth percentile on a teacher-developed test; or have a grade of C or below in the school year that just ended.

With the devastation the COVID-19 pandemic has caused, it is imperative now, more than ever, that we provide our students every opportunity to participate in quality education services with the fewest number of obstacles in their way. It is especially important to provide these opportunities to our youngest learners as our public schools build the foundation of their learning.

Selecting students only in the need of remediation poses the risk of missing or overlooking struggling students who may need the extra foundational instruction in mathematics and reading to enable their success. In addition, providing all students (including those who are average or above average) the extra support in the summer can prevent the "summer slide." The summer slide is a decline in reading ability and other academics during the summer months. Extensive research has been conducted on this phenomenon, and it has been concluded that up to 20% of school-year gains in reading and up to 27% of school-year gains in mathematics can be lost during the summer. These are learning losses we cannot afford.

Before crossover, your colleagues in the Environment & Education House Appropriations subcommittee were presented several options to accelerate the learning recovery of our students this biennium; offering a summer school option to all students, especially of our youngest learners, was one of these options. For this to happen NDCC 15.1-21-16 needs to be adjusted to align with that learning recovery work.
