A BILL for an Act to amend and reenact sections 43-47-01, 43-47-04, 43-47-05, and 43-47-06 of the North Dakota Century Code, relating to licensure of professional counselors designated supervised; and to provide for application.

The Century Code change proposed should not effect how the NDBCE oversees licensure.

Regarding the Licensure Statues and the NDBCE:

All of the NDBCE board's current licensure requirements and all administration of the licensures should stay the same.

This is only a simple language change of the LAPC.

***Note from discussion:** I would avoid the LPC-S title (just use LPC *designated supervised, so that counselors can just sign their notes as an LPC), and follow the MN model, as LPC-S could possibly be confused again as 3-Tier. Just follow the MN Model for language, as BCBS is reimbursing new Masters in Counseling graduates there.*

MN Counseling Agencies, such as Birch Counseling of Golden Valley MN, (866) 522-2472, and Minnesota Mental Health Clinincs (612) 746-5888 that their new graduates sign their notes as "LPC", are supervised by an LPCC, and are reimbursed by BCBS.

I believe your simplest solution as NDBCE board, if this legislation is passed, would be to consider the effective date of the legislation and:

On that date,

1. Current LAPC-blanket reissue all existing LAPC Licenses to LPC *designated supervised
 - Change that title and designation on your web site listing of counselors
 - Mail out new license cards
 - Drop the LAPC title entirely as of that date
2. Current LPC-not change.
3. Current LPCC- not change.

Few, if any, of your licensure structure or supervision rules would need to change. It would be busines as usual.

In a single day, you would convert completely in ND to LPCC, LPC and LPC * designated supervised, similar to the Minnesoata model.

My name is Greg Molinaro MS, LPC and I am a Licensed Mental Health Counselor in the state of North Dakota. I live in District 7, at 4016 Heartland Drive, Bismarck, 58503. The following information I am sharing is from my professional counseling experiences, observations in the agencies I have practiced, and recent conversations with the North Dakota Board of Counseling Examiners, heads of the Masters in Counseling programs at locations across North Dakota, and Counseling Agencies in Minnesota who accept BCBS.

I am an individual citizen who proposed this change to the board and am in cooperation with them.

Problem Identified: There is an unnecessary barrier to access to Mental Health Counseling in North Dakota and a simple change to the language in the ND Century Code could correct it.

(Referencing ND Century Code “CHAPTER 43-47 COUNSELORS”—attached and highlighted)

- Currently, in North Dakota, we have three Tiers of Licensure: **LAPC, LPC, and LPCC**.
- In contrast, in Minnesota, they have two tiers: **LPC** (*designated supervised, or *designated independent after their supervision period), and **LPCC**
- Important note: In Minnesota, new Master’s in Counseling graduates can be reimbursed for services by BCBS, because they only have a single tier to supervision by an LPCC
- In contrast, in North Dakota, BCBS requires a two year wait for reimbursement qualification, because Master’s in Counseling graduates have the LAPC license, and BCBS have consistently refused it saying it is a two-tier supervision (LAPC > LPC > LPCC), and must wait until they achieve LPC status for BCBS to reimburse.
 - Just as a reference, Sanford insurance currently reimburses for **LAPC** in the state of North Dakota, so they are not at issue here.

Imagine then, the reality, that in the state of North Dakota, if you have BCBS insurance, you cannot access counseling with all the new Master’s in Counseling graduates. For two years! That is a tragic barrier to access for too many North Dakotans, Ironically, many of those new graduates go with many unfilled timeslots for most of those first two years until BCBS begins reimbursement. Available timeslots for counseling go unfilled because one of the top providers of mental health coverage, BCBS, will not cover the services.

I want to highlight this again. Many new Master’s in Counseling graduates have unfilled AVAILABLE spaces in their counseling schedule during their first two years. Filling those open counseling slots could help narrow the gap of our mental health counseling needs and easily address and assist in the mental health crisis and shortage we are currently facing. With only a simple change to the titles of our licensed counselors in the ND Century Code, and BCBS reimbursing services to our new graduates, those empty slots can be filled, and many more North Dakotas could be served.

Solution Proposed: To ask the current legislative assemble to make a change to ND Century Code (CHAPTER 43-47 COUNSELORS).

The proposal would be only for a change in the current Century Code language:

- The titles: from, **LAPC**, to **LPC * designated supervised**
- The descriptions: “**associate professional counselor**” to “**Licensed Professional Counselor-supervised**”.
- The descriptions: “**Licensed associate professional counselor**” to “**Licensed Professional Counselor**”.
Very little, if anything, would change in actual agency practice or NDBCE oversight and licensing.

(There is a second benefit to the licensure name change.

- 1) The NHSC Rural Community Loan Repayment Program, located at <https://nhsc.hrsa.gov/loan-repayment/nhsc-rural-community-loan-repayment-program> does not recognize **LAPC** for the federal program, only **LPC** and above. New graduates, who may be willing to serve in rural, underserved areas for two years if they could partner with those communities and this federal program for student loan reimbursement, are denied that opportunity. The federal program begins at **LPC**, so currently new graduates must wait for two years to qualify. This is a barrier to opportunities and motivation for new graduates to serve at least half-time in a rural, underserved setting, and provide needed services to these valuable rural communities.

HOW TO READ THIS TABLE**Currently there are no counselors under discipline.**

Read the license number 100-1-1-00 as follows: the first set of numbers are the individual's specific number (100th to become licensed in the state of ND), and original license was granted 1-1-00. **IF** the date is followed by an additional set of numbers (100-1-1-00-**100**), that counselor advanced to the clinical, or LPCC, licensure. The expiration date for the counselor holding both LPC and LPCC licenses is the original expiration date set at the time of original, or initial, licensure. The date of the LPCC licensure is listed in a separate column, but has no bearing on the expiration date, as the two licenses are merged as one and listed as LPCLPCC.

The "A" behind the year of licensure (100-1-1-00A) indicates "associate" or LAPC, and the "A" is removed when the LAPC advances to LPC.

The SCert# column indicates the counselors who are certified as supervisors in the state of ND. Expiration date is also noted.

To calculate date of issue of certification, certification renews every five years.

Good morning Madam Chairwoman and members of the Senate Human Services Committee.

My name is Marge Ellefson. I am the executive secretary for the NDBCE (North Dakota Board of Counselor Examiners), and I am here by the authority of the Board to present opposition testimony on SB2335.

On January 18, 2021, the NDBCE was informed of a potential bill that would change the license title of the LAPC (Licensed Associate Professional Counselor) to either LPC-designated supervised or Professional Counselor-supervised. The exact title was not consistent in SB2335 which the NDBCE saw for the first time on Tuesday, January 26, 2021. It was also suggested to this board that the LPC license now be changed to LPC-independent. These changes could involve issuing as many as 275 new licenses. The Board does not feel it was given ample or appropriate time to effectively or efficiently research what impacts these changes would have on several levels. The LAPC is already known as under supervision, and the LPC is already known as independent.

In a special board meeting held Friday, January 29, 2021, the board discussed the proposed changes, impacts and concerns raised by SB2335. Although the bill does not reflect the reason for these proposed changes, from additional information given to this board it appears this is an attempt to alter the title to align with Blue Cross Blue Shield. This board is not involved with insurance companies and their policies for reimbursement. The purpose of this regulatory board is to license competent counselors to serve the people of North Dakota. It is believed that BCBS may have a misconception of the board's licensure tiers. Although the insurance company recognizes and reimburses LPC's, renaming the LAPC will not bring that license to the LPC level of independent practice. Any misconceptions would need to be addressed between counselors/agencies and insurance providers.

In a recent publication of BCBS (provided in my submitted written testimony) it states they recognize LPC's. The board is concerned because having two licenses with similar titles could cause confusion between one under supervision and one not under supervision. Would BCBS recognize the LPC-under supervision in the same category as the LPC independent? There is still the distinction between them which is the supervision status. Changing titles will not eliminate the difference between the two.

To reiterate, changing the title of the LAPC will not change the structure of the license or the fact that the counselor is under two years of supervised experience post-degree. As such, regardless of the title (LAPC or LPC-Under supervision), the counselor's activities will still be under supervision, which insurance companies may or may not decide to reimburse. It was also mentioned to this board that NHSC Rural Community Loan Repayment Program does not recognize the LAPC, only the LPC, for qualification. This board suggests NHSC may be looking at licenses under supervision vs independent licenses. Changing the title of the LAPC could be deceiving, because it may look like a full license to those who are unaware the new title (LPC – Under supervision) is re-naming a license under supervision (LAPC). The NHSC website states the Community Loan Repayment Program only applies to **fully trained and licensed to practice counselors**. The LPC-under supervision does not meet those qualifications any

more than an LAPC title does. A board member remembers this program from the past and they required fully licensed applicants.

It was also noted that several insurance providers recognize and reimburse the LAPC. The board is concerned that changing the LAPC title could cause unintended consequences and interfere with reimbursement processes already in place from other providers.

On a side note, this board has been in conversations for a while now about going from a three-tier licensure structure to a two-tier licensure structure. Would going forward with these proposed changes interfere with or confuse the board's current research and intent to get to two tiers? Further, would this mean the board would go through the work, the time and the expense now, only to repeat the lengthy process again in the future when the two-tier structure becomes feasible?

Making a title change like this is not as simple as four or five references in the Century Code. The changes that would need to be made would begin with:

- Changing the Admin Code and all references to the LAPC and/or LPC, if necessary. There is an expense to doing that which is not reflected in the bill or any fiscal notes that the board is aware of. Changing the Administrative Code to reflect the Century Code involves at minimum a notice in all county newspapers, legal expense for wording and procedure, and holding a public hearing before anything else could be done.
- Re-license all LAPC's and possibly all LPC's, which may result in a cost to the license holder for a new license issued.
- All agencies or institutions that currently receive reimbursement for LAPC's would need to contact all their insurance providers to assess any impact this title change would have.
- Go through the website and change all forms or any documents with reference to LAPC (or LPC if that title has to be changed, as well).
- Contacting universities, local and nation-wide, including distance learning facilities, who offer counseling programs to explain the change in the title and to address confusion when advising their students.
- Contacting and making the changes to all national organizations that compare all states and their requirements in national publications or have this information for their own reference. This would include (but not be limited to) ACA (American Counseling Association), AASCB (American Association of State Counseling Boards), and NBCC (National Board for Certified Counselors). The LAPC title is associated with this board in several other places, including references on internet when this board is searched.

I apologize for the length of this testimony, however, changing a long standing title (traced back to 1998) is far more complicated than one would think, and the board is concerned a "simple" title change would be confusing, even to the consumer. The board does not see an advantage to this. Thank you for your time.

I am happy to stand for any questions.

My name is Hailey and I am a student training to become a Clinical Mental Health Counseling in the Master's program at the University of Mary. This change in how Mental Health Counselors are recognized is very important to me.
