December 5-7, 2022 (Monday through Wednesday)		Organizational session <sup>1</sup>
December 8 (Thursday)		Deadline for executive agencies and Supreme Court to file bills with the Legislative Council
December 16 (Friday)		Deadline for legislators to submit health insurance mandate bills to the Legislative Council
January 3, 2023 (Tuesday)	1 <sup>st</sup>	Session begins <sup>1</sup> (Tribal-State Relationship Message, State of the Judiciary address, and State of the State address)
January 4 and 5 (Wednesday and Thursday)		No floor sessions, standing committees will meet
January 9 (Monday)	3 <sup>rd</sup>	No more than five bills may be introduced by each Representative after this date
January 16 (Monday)	8 <sup>th</sup>	Martin Luther King Day. <sup>2</sup> Deadline for Representatives to introduce bills. No more than three bills may be introduced by each Senator after this date. A Senate bill containing an appropriation clause may not be introduced after this date.
January 23 (Monday)	13 <sup>th</sup>	Deadline for Senators to introduce bills
January 26 (Thursday)	16 <sup>th</sup>	Deadline for introducing resolutions except amendments to the Constitution of North Dakota and study resolutions
February 6 (Monday)	23 <sup>rd</sup>	Deadline for rereferrals of bills in house of origin to Appropriations Committees
February 20 (Monday)	33 <sup>rd</sup>	George Washington's Birthday <sup>2</sup>
February 21 (Tuesday)	34 <sup>th</sup>	Bills and resolutions except constitutional amendments and study resolutions must be reported out of committee in house of origin. Deadline for introducing amendments to the Constitution of North Dakota and study resolutions.
February 24 (Friday)	37 <sup>th</sup>	Crossover date for bills <sup>3</sup>
February 27 and 28 (Monday and Tuesday)		Recess
March 1 (Wednesday)	38 <sup>th</sup>	Reconvene from crossover break
March 3 (Friday)	40 <sup>th</sup>	Study resolutions and proposed constitutional amendments must be reported out of committee
March 8 (Wednesday)	43 <sup>rd</sup>	Crossover date for resolutions
March 24 (Friday)	55 <sup>th</sup>	Deadline for rereferrals of bills in second house to Appropriations Committees
April 5 (Wednesday)	63 <sup>rd</sup>	Bills and resolutions must be reported out of committee in second house
April 7 (Friday)	65 <sup>th</sup>	Good Friday <sup>2</sup>
April 28 (Friday)	80 <sup>th</sup>	Session limited to 80 legislative days <sup>4</sup>

<sup>2</sup>In 2021 the House and Senate were in session on Martin Luther King Day and George Washington's Birthday. Generally, both the House and the Senate have been in session on Good Friday.

<sup>3</sup>In 2021 the House and Senate made crossover on the 35<sup>th</sup> legislative day, Wednesday, February 24.

<sup>4</sup>Section 7 of Article IV of the Constitution of North Dakota limits regular sessions to 80 natural days during a biennium and defines a "natural day" as a period of 24 consecutive hours. House and Senate Rules 104 provide that a legislative day begins at 7:00 a.m., so each legislative day ends at 7:00 a.m. the following day.
