Testimony House Bill No. 1165 House Human Services Committee Representative Robin Weisz, Chairman January 11, 2023

Chairman Weisz, and members of the House Human Services Committee, I am Jonathan Alm, an attorney with the Department of Health and Human Services (Department). I appear before you in support of House Bill No. 1165.

This Bill does the following:

- Replaces executive director of the Department with commissioner of the Department. (Sections 1, 2, 16, 22, 27, 28, 41, 58, 61, 62, 63, 65, 66, 68, 69, 70, 71, 72, 73, 74, 75, 76, 86, 101, 108, 109, 110, 111, 112, 113, 114, 115, 116, 117, 118, 119, 120, 121, 122, 125, 126, 127, 128, 129, 130, 132, 133, and 134)
- Adds "designee" after commissioner of the Department and state health officer to allow both positions to delegate certain tasks and duties. (Sections 1, 2, 5, 63, 65, 66, 75, 76, 78, 86, 105, 106, 111, 112, 114, 115, 116, 117, 120, 121, 125, 126, 127, 128, 130, and 132)
- 3. Updates language to reflect the integration of the Department of Human Services and State Department of Health and align with the current structure of the Department, including removing definitions no longer used in certain chapters and adding definition to certain chapters. (Sections 3, 23, 25, 31, 48, 64, 67, 102, and 104)
- 4. Replaces state health officer or executive director with the Department to clarify the function is not tied to the specific

position, but the Department. (Sections 4, 10, 11, 18, 19, 24, 26, 32, 40, 47, 49, 50, 53, 55, 56, 57, 59, 77, and 107)

- Removes state health council's tasks and duties and replaces state health council with the Department. The Department is aware of another proposed bill that will reestablish and clarify the tasks and duties of the state health council. (Sections 6, 7, 8, 9, 20, 21, 29, 30, 33, 34, 35, 36, 37, 38, 42, 43, 44, 45, 46, 49, 50, 51, 52, 54, 60, 79, 80, 81, 82, 83, 84, 85, 87, 88, 89, 90, 91, 92, 93, 94, 95, 96, 97, 98, 99, 100, 103, 104, 123, 124, 131, and 136)
- Replaces state health officer with commissioner of the Department to reflect the structure of the Department and post-integration duties and tasks. (Sections 12 and 17)

There are specific sections of this Bill that I will now discuss in more detail. (Sections 9, 13, 14, 15, 16, 39, 48, 61, 75, 109, 110, 111, 135, and 136)

Section 1:

NORTH

Section 1 of this Bill amends subdivision p of subsection 1 of section 11-16-01 of the North Dakota Century Code to replace "executive director" with "commissioner" regarding the Department and to add "or designee".

Section 2:

Section 2 of this Bill amends section 14-13-03 of the North Dakota Century Code to replace "executive director" with "commissioner" regarding the Department and to add "or designee".

Section 3:

Section 3 of this Bill amends subsection 2 of section 15-52-03 of the North Dakota Century Code updates the language based on the integration of the Department of Human Services and State Department of Health that one member of the school of medicine and health sciences



advisory council is the state health officer or designee with another member from the Department.

Section 4:

Section 4 of this Bill amends section 16.1-02-06 of the North Dakota Century Code replaces "state health officer" with the "department of health and human services" to clarify the function is not tied to the specific state health officer position, but the Department.

Section 5:

Section 5 of this Bill amends subsection 2 of section 19-24.1-38 of the North Dakota Century Code to add "or designee" after state health officer.

Section 6:

Section 6 of this Bill amends section 23-01-03.1 of the North Dakota Century Code replaces "health council" with "state health officer" and removes the requirement that the health council approves the advisory committee regarding newborn metabolic and genetic disease.

Section 7:

Section 7 of this Bill amends section 23-01-03.3 of the North Dakota Century Code replaces "state health council" with "department of health and human services" regarding the administration of the long-term care nursing scholarship and loan repayment grant program.

Section 8:

Section 8 of this Bill amends section 23-01-04.3 of the North Dakota Century Code replaces "state health council" or "council" with "department of health and human services" regarding the alternative health care services pilot project.

Section 9:

Section 9 of this Bill amends section 23-01-05 of the North Dakota Century Code outlines and updates the state health officer duties and tasks. The proposed amendment removes the reference of the health



council promulgating regulations, as the Department performs those tasks and removes several tasks and duties of the state health officer. A majority of the duties removed from the state health officer were moved into the duties and tasks of the public health division and central public health laboratory of the Department in Sections 13 and 14 of this Bill. This Bill also adds and clarifies the duties and tasks of the state health officer based on the integration of Department of Human Services and State Department of Health.

Section 10:

Section 10 of this Bill amends section 23-01-05.1 of the North Dakota Century Code removes "executive director of the" to clarify the function is not tied to the specific executive director position, but the Department.

Section 11:

Section 11 of this Bill amends subsection 3 of section 23-01-05.3 of the North Dakota Century Code replaces "state health officer" with "department of health and human services" to clarify the function is not tied to the specific state health officer position, but the Department.

Section 12:

Section 12 of this Bill amends section 23-01-05.4 of the North Dakota Century Code replaces "state health officer" with "commissioner of the department of health and human services" to clarify the structure of the Department.

Section 13:

Section 13 of this Bill creates a new section to chapter 23-01 of the North Dakota Century Code regarding the powers and duties of the public health division of the Department. The powers and duties of the public health division reflect the powers and duties that were outlined in section 23-01-05 regarding the state health officer duties and tasks and in other areas of the North Dakota Century Code. The proposed changes do not



expand the powers and duties of the Department besides taking on some of the duties and tasks performed by the state health council, such as working on administrative rules.

Section 14:

Section 14 of this Bill creates a new section to chapter 23-01 of the North Dakota Century Code regarding the powers and duties of the central public health laboratory of the Department that were outlined in section 23-01-05 regarding the state health officer's duties and tasks. The proposed changes do not expand the powers and duties of the Department.

Section 15:

Section 15 of this Bill creates a new section to chapter 23-01 of the North Dakota Century Code regarding the Department ability to employ staff to deploy to local hospitals, basic care facilities, long-term care facilities, and other health care settings to cover staff shortages.

Section 16:

Section 16 of this Bill amends section 23-01-08 of the North Dakota Century Code replaces "executive director" with "commissioner" regarding the Department and to clarify that the state health officer may appoint a deputy state health officer, instead of the executive director of the Department or designee making that appointment.

Section 17:

Section 17 of this Bill amends section 23-01-08.1 of the North Dakota Century Code replaces "state health officer" with the commissioner regarding the Department to reflect the organizational structure of the Department.

Section 18:

Section 18 of this Bill amends section 23-01-12 of the North Dakota Century Code replaces "state health officer" with "department" or



"department of health and human services" to clarify the function is not tied to the specific state health officer position, but the Department.

Section 19:

Section 19 of this Bill amends subsection 3 of section 23-01-44 of the North Dakota Century Code replaces "state health officer" with "department of health and human services" to clarify the function is not tied to the specific state health officer position, but the Department.

Section 20:

Section 20 of this Bill amends section 23-01.2-01 of the North Dakota Century Code removes the "health council, in conjunction with the" and "as determined by the health council" from the requirement to establish and maintain a comprehensive trauma system.

Section 21:

Section 21 of this Bill amends section 23-01.2-03 of the North Dakota Century Code replaces "state health council" with "department of health and human services" regarding the allowance of reasonable amount of time for a hospital to fully meet all trauma designation standards.

Section 22:

Section 22 of this Bill amends section 23-01.2-04 of the North Dakota Century Code replaces "executive director" with "commissioner" regarding the Department.

Section 23:

Section 23 of this Bill amends subsection 8 of section 23-01.3-01 of the North Dakota Century Code adds "public" to reflect the division's proper name.

Section 24:

Section 24 of this Bill amends subsection 1 of section 23-01.3-06 of the North Dakota Century Code replaces "state health officer" with



"department of health and human services" to clarify the function is not tied to the specific state health officer position, but the Department.

Section 31 of this Bill amends section 23-07.2-01 of the North Dakota Century Code reorganizes the section and removes "state health officer" as a defined term as it is not used in chapter 23-07.2 of the North Dakota Century Code.

Section 32:

Section 32 of this Bill amends section 23-09.4-08 of the North Dakota Century Code replaces "state health officer" with "department" to clarify the function is not tied to the specific state health officer position, but the Department.

Section 33:

Section 33 of this Bill amends subsection 4 of section 23-10-03 of the North Dakota Century Code replaces "health council" with "department" regarding the adoption of rules.

Section 34:

Section 34 of this Bill amends section 23-10-06 of the North Dakota Century Code replaces "health council" with "department" regarding the adoption of rules.

Section 40 of this Bill amends section 23-16-11 of the North Dakota Century Code adds "of health and human services" after "department" and replaces "state health officer" with "department of health and human services" to clarify the function is not tied to the specific state health officer position, but the Department.

Section 41:

Section 41 of this Bill amends section 23-17-08 of the North Dakota Century Code replaces "executive director" with "commissioner" regarding the Department and adds "or designee".

Section 42:

Section 42 of this Bill amends section 23-17.6-01 of the North Dakota Century Code replaces "health council" with "department" regarding the adoption of rules in the definition of operating room.

Section 23-01-06 would remove the redundant provision that requires the Department to file a biennial report to the Governor and



Secretary of State in accordance with section 54-06-04 of the North Dakota Century Code as the Department is already listed in section 54-06-04 of the North Dakota Century Code. Section 23-07-07 is being repealed as it is outdated and covered by authority in other laws.

Chairman Lee, and members of the Senate Human Services Committee, I am Jonathan Alm, an attorney with the Department of Health and Human Services (Department). I appear before you in support of House Bill No. 1165.

This Bill does the following:

- Replaces executive director of the Department with commissioner of the Department. (Sections 1, 2, 16, 22, 27, 28, 41, 58, 61, 62, 63, 65, 66, 68, 69, 70, 71, 72, 73, 74, 75, 76, 86, 101, 108, 109, 110, 111, 112, 113, 114, 115, 116, 117, 118, 119, 120, 121, 122, 125, 126, 127, 128, 129, 130, 132, 133, and 134)
- Adds "designee" after commissioner of the Department and state health officer to allow both positions to delegate certain tasks and duties. (Sections 1, 2, 5, 63, 65, 66, 75, 76, 78, 86, 105, 106, 111, 112, 114, 115, 116, 117, 120, 121, 125, 126, 127, 128, 130, and 132)
- 3. Updates language to reflect the integration of the Department of Human Services and State Department of Health and align with the current structure of the Department, including removing definitions no longer used in certain chapters and adding definitions to certain chapters. (Sections 3, 23, 25, 31, 48, 64, 67, 102, and 104)
- Replaces state health officer or executive director with the Department to clarify the function is not tied to the specific position, but the Department. (Sections 4, 10, 11, 18, 19, 24, 26,



32, 40, 47, 49, 50, 53, 55, 56, 57, 59, 77, and 107)

- Removes state health council's tasks and duties and replaces state health council with the Department. The Department is aware of another proposed bill, Senate Bill No. 2227, that will reestablish and clarify the tasks and duties of the state health council. (Sections 6, 7, 8, 9, 20, 21, 29, 30, 33, 34, 35, 36, 37, 38, 42, 43, 44, 45, 46, 49, 50, 51, 52, 54, 60, 79, 80, 81, 82, 83, 84, 85, 87, 88, 89, 90, 91, 92, 93, 94, 95, 96, 97, 98, 99, 100, 103, 104, 123, 124, 131, and 136)
- Replaces state health officer with commissioner of the Department to reflect the structure of the Department and post-integration duties and tasks. (Sections 12 and 17)

There are specific sections of this Bill that I will now discuss in more detail. (Sections 9, 13, 14, 15, 16, 38, 39, 48, 61, 75, 109, 110, 111, 135, and 136)

Section 1:

Section 1 of this Bill amends subdivision p of subsection 1 of section 11-16-01 of the North Dakota Century Code to replace "executive director" with "commissioner" regarding the Department and to add "or designee".

Section 2:

Section 2 of this Bill amends section 14-13-03 of the North Dakota Century Code to replace "executive director" with "commissioner" regarding the Department and to add "or designee".

Section 3:

Section 3 of this Bill amends subsection 2 of section 15-52-03 of the North Dakota Century Code updates the language based on the integration of the Department of Human Services and State Department of Health that one member of the school of medicine and health sciences



advisory council is the state health officer or designee with another member from the Department.

Section 4:

Section 4 of this Bill amends section 16.1-02-06 of the North Dakota Century Code replaces "state health officer" with the "department of health and human services" to clarify the function is not tied to the specific state health officer position, but the Department.

Section 5:

Section 5 of this Bill amends subsection 2 of section 19-24.1-38 of the North Dakota Century Code to add "or designee" after state health officer.

Section 6:

Section 6 of this Bill amends section 23-01-03.1 of the North Dakota Century Code replaces "health council" with "state health officer" and removes the requirement that the health council approves the advisory committee regarding newborn metabolic and genetic disease.

Section 7:

Section 7 of this Bill amends section 23-01-03.3 of the North Dakota Century Code replaces "state health council" with "department of health and human services" regarding the administration of the long-term care nursing scholarship and loan repayment grant program.

Section 8:

Section 8 of this Bill amends section 23-01-04.3 of the North Dakota Century Code replaces "state health council" or "council" with "department of health and human services" regarding the alternative health care services pilot project.

Section 9:

Section 9 of this Bill amends section 23-01-05 of the North Dakota Century Code outlines and updates the state health officer duties and tasks. The proposed amendment removes the reference of the health



council promulgating regulations, as the Department performs those tasks and removes several tasks and duties of the state health officer. A majority of the duties removed from the state health officer were moved into the duties and tasks of the public health division and central public health laboratory of the Department in Sections 13 and 14 of this Bill. This Bill also adds and clarifies the duties and tasks of the state health officer based on the integration of Department of Human Services and State Department of Health.

Section 10:

Section 10 of this Bill amends section 23-01-05.1 of the North Dakota Century Code removes "executive director of the" to clarify the function is not tied to the specific executive director position, but the Department.

Section 11:

Section 11 of this Bill amends subsection 3 of section 23-01-05.3 of the North Dakota Century Code replaces "state health officer" with "department of health and human services" to clarify the function is not tied to the specific state health officer position, but the Department.

Section 12:

Section 12 of this Bill amends section 23-01-05.4 of the North Dakota Century Code replaces "state health officer" with "commissioner of the department of health and human services" to clarify the structure of the Department.

Section 13:

Section 13 of this Bill creates a new section to chapter 23-01 of the North Dakota Century Code regarding the powers and duties of the public health division of the Department. The powers and duties of the public health division reflect the powers and duties that were outlined in section 23-01-05 regarding the state health officer duties and tasks and in other areas of the North Dakota Century Code. The proposed changes do not



expand the powers and duties of the Department besides taking on some of the duties and tasks performed by the state health council, such as working on administrative rules.

Section 14:

Section 14 of this Bill creates a new section to chapter 23-01 of the North Dakota Century Code regarding the powers and duties of the central public health laboratory of the Department that were outlined in section 23-01-05 regarding the state health officer's duties and tasks. The proposed changes do not expand the powers and duties of the Department.

Section 15:

Section 15 of this Bill creates a new section to chapter 23-01 of the North Dakota Century Code regarding the Department ability to employ staff to deploy to local hospitals, basic care facilities, long-term care facilities, and other health care settings to cover staff shortages.

Section 16:

Section 16 of this Bill amends section 23-01-08 of the North Dakota Century Code replaces "executive director" with "commissioner" regarding the Department and to clarify that the state health officer may appoint a deputy state health officer, instead of the executive director of the Department or designee making that appointment.

Section 17:

Section 17 of this Bill amends section 23-01-08.1 of the North Dakota Century Code replaces "state health officer" with the commissioner regarding the Department to reflect the organizational structure of the Department.

Section 18:

Section 18 of this Bill amends section 23-01-12 of the North Dakota Century Code replaces "state health officer" with "department" or

Section 135 of this Bill amends section 57-60-03 of the North Dakota Century Code replaces "state health officer" with "department of environmental quality" to reflect the proper location for an operator of any coal gasification plan to file a report listing the quantity of byproducts produced during the year.

Section 136:

Section 136 of this Bill repeals sections 23-01-01, 23-01-02, 23-01-03, 23-01-06, and 23-07-07 of the North Dakota Century Code. Section 23-01-01 is no longer needed due to the integration of the Department of Human Services and the State Department of Health and the removal of the state health council. Sections 23-01-02 and 23-01-03 is regarding the creation of the state health council and powers and duties of the health council. Section 23-01-06 would remove the redundant provision that requires the Department to file a biennial report to the Governor and Secretary of State in accordance with section 54-06-04 of the North Dakota Century Code as the Department is already listed in section 54-



06-04 of the North Dakota Century Code. Section 23-07-07 is being repealed as it is outdated and covered by authority in other laws.

HB 1165 – Proposed Amendment

Amendment. Section 23-17.3 of the North Dakota Century Code is amended and reenacted as follows:

23-17.3-01. Definitions.

- "Home health services" means a broad range of health and social services furnished to individuals and families by a home health agency or by others under arrangements with the agency, in the places where the recipients are presently residing. Services must include the services of a currently licensed registered professional nurse and at least on other therapeutic services and may include additional support services. These services may only be provided with the approval of a licensed physician <u>or an allowed practitioner.</u>
- 2. <u>"Allowed Practitioner" means a physician assistant (PA), nurse practitioner (NP),</u> or clinical nurse specialist (CNS).

23-17.3-05 Standards of licensure.

- The agency shall have a supervising physician or a supervising registered professional nursean allowed practitioner who is responsible for the direction, coordination, and general supervision of the therapeutic services provided by the agency and who is employed on a full-time basis. There must be supervision from a physician or registered professional nurseallowed practitioner during all hours of operation.
- 2. The agency shall maintain clinical records on all patients to serve as documentation of the medical, nursing, and therapeutic care rendered to the patient and for communication between the physician <u>or allowed practitioner</u> and the agency.
