# TESTIMONY OF MAJOR JAY SHELDON NORTH DAKOTA NATIONAL GUARD BEFORE THE HOUSE GOVERNMENT AND VETERANS AFFAIRS COMMITTEE 19 JANUARY 2023 HOUSE BILL 1182

Good morning, Chairman Schauer, members of the committee, I am Jay Sheldon, Strategy and Policy Officer for the North Dakota National Guard (NDNG). I am here today to testify in support of House Bill 1182

The NDNG supports the establishment of a state sponsored Military Funeral Burial Stipend that is like programs that exist in Minnesota and South Dakota. We have worked closely with Rep. Matt Ruby and Commissioner Wangen in the preparation of this bill.

The NDNG manages a federally funded Military Funeral Honors program which can provide a stipend to Veteran Service Organizations (VSO). However, our program has limited funds and rules that restrict who is eligible for the stipend. Under these rules the NDNG can only provide the stipend for Army funerals that has a live bugler.

These rules significantly reduce the number of VSOs eligible to receive a stipend. The program being proposed would authorize a stipend for congressionally chartered VSOs that provide the key elements of honor for members of all branches of service and regardless of how the honor of Taps is performed. VSOs would NOT receive both a state and federal stipend.

We feel this stipend, although minimal, will ensure that appropriate honors are provided to eligible military members in the future.

I ask for your support of HB 1182 and will stand by for any questions that you may have.



Mr. Chairman and members of the committee,

Thank you for your consideration of HB 1182. This bill would create a reimbursement fund for Veteran Service Organizations that provide one of the services of a military veteran's funeral. Currently the Department of the Army has a reimbursement of \$50 if a VSO plays a live bugle at a funeral. There aren't many live buglers in the state anymore. During my time as a team leader of the Military Funeral Honors program I covered the northwest part of the state from Rugby to Montana, and McClusky and Watford City to Canada. I have presented flags to cameras, the lone attendee that had coffee with the veteran, and numerous funeral directors when there was nobody in attendance. I had 3 live buglers in the entire area. The only constant, aside from a funeral director, was the Veteran Organizations that sometimes had just a handful of guys to render a 3 volley salute. More often than not, my partner or I would play a high quality recording of TAPS that was inserted into a bugle. What this bill proposes is to create a \$50 reimbursement for a VSO that does one of the five parts of a veterans funeral. The 5 parts are the folding of the US Flag, presentation of the US Flag, presentation of the ND State Coin, playing of TAPS, and the 3 volley Salute. Only one VSO can claim this reimbursement and the intent is that they would first attempt to get the federal reimbursement. If they do receive that they wouldn't be able to get the state reimbursement.

To put this into numerical terms, its estimated that 60% of all military funerals in ND are Army veterans and out of those only about 30% had a live bugle to qualify for the Federal reimbursement. Each branch does their own funerals and the ND Army National Guard averages about 765 funerals a year. Using those numbers, we are estimating about 1275 veteran funerals a year. Keep in mind that we can expect rise and falls that correlate with the gaps between major wars where our military numbers rose and fell. We came in on the high side with our ask of \$200,000 and we would understand a reduction if the committee felt that was necessary. The Department of Veteran Affairs has identified an existing fund that this money could be deposited and they would create the rules and process for reimbursement.

I hope you will approve this new program. This is a small amount that will go a long ways to maintain uniforms, help with travel costs and to maintain equipment. These services for veteran funerals are important to provide closure to the family and the final honors to the veteran. I respectfully ask for a Do Pass recommendation from the committee.

Good morning, Mr. Chairman, and members of the House Appropriations Committee.

My name is Austen Schauer, representing District 13 in West Fargo.

**House Bill 1182** establishes a state sponsored Military Funeral Burial Stipend similar to programs in Minnesota and South Dakota.

Currently, the North Dakota National Guard manages a **federally funded** Military Funeral Honors program which provides a \$50 stipend to Veteran Service Organizations (VSOs).

However, this program has **limited funds** and rules that restrict who is eligible for the stipend.

Under these rules, the National Guard can only provide the stipend for **Army funerals** that have a **live bugler**.

These rules significantly reduce the number of VSOs eligible to receive a stipend.

The program (under HB 1182) would authorize a \$50 stipend for congressionally chartered VSOs that provide the key elements of honor for members of ALL branches of service regardless of how the honor of Taps is performed. (A quality audio recording of Taps would be allowed).

VSOs would not receive both a state and federal stipend.

As you know, funeral Honors include folding of the flag, presentation of the flag, presentation of the state coin, playing of the taps and a three-volley salute.

Even though the stipend is only **\$50**, many VSOs are struggling to financially support their Funeral Honors program.

The ask under this is **\$200 thousand dollars** in continuing appropriation to help cover the yearly average of **16 hundred funerals.** 

**HB 1182** passed **GVA** by a 12-0 mark and the full House by a **90-0** margin.

# TESTIMONY OF MAJOR JAY SHELDON NORTH DAKOTA NATIONAL GUARD BEFORE THE SENATE AGRICULTURE AND VETERANS AFFAIRS 16 MARCH 2023 HOUSE BILL 1182

Good morning, Chairman Luick, members of the committee, I am Jay Sheldon, Strategy and Policy Officer for the North Dakota National Guard (NDNG). I am here today to testify in support of House Bill 1182

The NDNG supports the establishment of a state sponsored Military Funeral Burial Stipend that is like programs that exist in Minnesota and South Dakota. We have worked closely with Rep. Matt Ruby and Commissioner Wangen in the preparation of this bill.

The NDNG manages a federally funded Military Funeral Honors program which can provide a stipend to Veteran Service Organizations (VSO). However, our program has limited funds and rules that restrict who is eligible for the stipend. Under these rules the NDNG can only provide the stipend for Army funerals that has a live bugler.

These rules significantly reduce the number of VSOs eligible to receive a stipend. The program being proposed would authorize a stipend for congressionally chartered VSOs that provide the key elements of honor for members of all branches of service and regardless of how the honor of Taps is performed. VSOs would NOT receive both a state and federal stipend.

We feel this stipend, although minimal, will ensure that appropriate honors are provided to eligible military members in the future.

I ask for your support of HB 1182 and will stand by for any questions that you may have.

Good morning Chairman Luick, Vice Chairman Myrdal, and Committee,

My name is Matt Ruby and I have the honor to represent District 40 in the ND House of Representatives. HB 1182 is a bill that would create a \$50 stipend for a Veteran Service Organization that performs one of the 5 parts of a military Veteran's funeral. Currently the North Dakota Army National Guard provides the honors for Army veterans and the other branches cover their own. In most areas there is a VSO that also provide honors. When I was a team leader in the Military Funeral Honors Program covering the northwest quadrant of the state, we typically provided the folding of the U S Flag and the presentation to the family but it's not uncommon for us to play TAPS with a recorded version that is played from an insert that goes inside a bugle as well. The VSO typically provides the 3 Volley Salute, the playing of TAPS when they can and present the state coin to the family. The Department of the Army will provide a \$50 stipend if the VSO plays a live bugle at an Army veteran's funeral only, but there are only a handful of VSOs across the state that have someone that plays live TAPS. South Dakota created a stipend program to help cover down for the other branches and for those VSOs that don't have a live bugler and the intent is that we would model our program after theirs. About 60% of the roughly 1275 veteran funerals across the state in the last year were Army and a very small portion of those qualified for the stipend from the department of the Army. This isn't a big amount per funeral but it goes a long way to help pay for transportation, uniforms and training so a veteran gets the proper final respect they deserve.
