Testimony in Opposition for HB 1275

To the Honorable Chairman and the members of the Committee We submit these remarks on behalf of DRC.

Mr. Chairman,

The Dakota Resource Council has worked towards checkoff reform for years in pursuit of fair markets for cattle. While we believe that this bill could be a positive step forward in transparency in the application process for the check off board members we believe that there are better options available for you to pass today. We still believe that direct democracy is better than the appointment of individuals by an elected official. More applications would mean more options but ultimately it's up to the governor to decide who gets in or wants to stay away from certain reforms. The way the current system is set up will only work towards keeping the status quo and real reform is needed in the Beef Commission.

If HB1436 is passed there will be no need for this bill.

We recommend a DO NOT PASS VOTE.

## House Bill 1275 does the following:

- Amends the application process for individuals seeking membership as an at-large representative on the Beef Commission. The individual seeking membership shall complete and submit an application in accordance with section 2 of this Act. Additionally, the application period is defined as opening on March first and closing on May first.
- 2. Adds a new section to chapter 4.1-03, Beef Commission. Section 2 of this proposed legislation defines the notice process when the term of an atlarge representative is scheduled to expire. Section 2 follows.

At-large representatives - Expiring terms - Notice.

- 1. When the term of an at large representative is scheduled to expire, the commission shall publish a notification, beginning in March of that year, once per month for two consecutive months in the official newspaper of each county. The notification must include:
  - a. A statement indicating applications are being accepted for an at-large representative member on the commission;
  - b. Instructions for obtaining an application form;
  - c. The deadline to submit an application;
  - d. Submission instructions for a completed application; and
  - e. The length of the term of office.
- 2. Beginning on March first, the commission shall post on the commission's website a notification that includes the information provided in subsection 1 in a year when the term of an at large representative is scheduled to expire. The notification must remain posted until the application period closes

Your favorable consideration of House Bill 1275 is appreciated.

My name is Frank Tomac, cattle rancher from Sioux County ND.

I am opposed to HB 1275. This bill does nothing to solve the issue of membership on the ND Beef Commission.

First of all it requires every applicant to submit an application between the busiest and most crucial time of the year. March  $1^{st}$  to May  $1^{st}$ .

Second, it's only gonna be published in each counties local paper <u>TWICE</u> for each at-large position! How many people read the local paper? It's a dying form of communication.

But it will also be published on the ND Beef Commission website. If you've ever been on the ND Beef Commission website, it's one of the most difficult sites to navigate, especially for anyone with limited computer time. It definitely is not cowboy friendly.

One other thing this bill does NOT do, is specify a deadline for the appointment to be filled! This last appointment by the Governor was filled on October  $27^{th}$ ! Well past the start of the July  $1^{st}$  fiscal year.
