TESTIMONY PRESENTED BY

MICHAEL HOWE, SECRETARY OF STATE

Chairman Schauer and members of the committee, I am Michael Howe, Secretary of State. I am here to give insight into current practices and highlight areas that may need more clarity in House Bill 1441.

This proposed legislation seeks to create greater reporting responsibilities for multi-candidate committees. Many of the changes suggested here are very similar to reporting requirements that already exist for PACs within our state. PACs currently submit an itemized listing of expenditures, where multi-candidate committees submit expenses in categories.

We believe, based on the intention of this legislation, that amending this bill to mirror the same reporting requirements for PACs would address the issue more clearly, reduce confusion, and potentially eliminate costs. The reporting requirements as proposed would require significant programming changes to our current campaign finance reporting system and likely would require a fiscal note for us to fully implement this legislation.

TESTIMONY PRESENTED BY

LEE ANN OLIVER, ELECTIONS – SECRETARY OF STATE

Chairman Roers and members of the committee, I am Lee Ann Oliver with the Elections Division at the Office of the Secretary of State.

Due to the numerous bills this session that seek to bring forth changes in campaign finance laws, we encourage the legislative assembly to amend this bill into House Bill 1529 which is before this committee tomorrow. House Bill 1529 now seeks an interim study to look at North Dakota's campaign finance laws.

We are seeking funding in Senate Bill 2002, the Secretary of State's budget, to fund a new campaign finance system. The Senate passed Senate Bill 2002 with that funding, and that proposal is now in front of House appropriations.

Our current campaign finance system is out of date and the functions are not easily changed. We are not certain that if 1441 is passed that it can be implemented as intended.

We urge the committee to amend House Bill 1441 into the interim study proposed in House Bill 1529.
